MUNICIPAL AND SCHOOL CERTIFICATION

As communities across the country struggle to make progress on sustainability goals, New Jersey's towns and schools are taking action and providing evidence of implementation. Sustainable Jersey's certification programs empower municipalities and schools to complete and document a set of rigorous standards that we call actions. The actions cover critical areas including resiliency, land use, public health, climate education, natural resource protection, transportation alternatives, green purchasing, energy and waste reduction, and more.

How We Drive Change

GRANTS, TECHNICAL ASSISTANCE AND TRAINING

We understand that implementing our recommended best practices requires significant capacity. That is why Sustainable Jersey connects participating communities with the financial and technical resources needed to complete actions and make progress towards a sustainable future. Multiple competitive grant and technical assistance opportunities funded by program underwriters and partner organizations are provided each year. In addition, trainings, workshops and webinars are made available to help participants move forward in the program. Through the Sustainable Jersey Grant Program, over \$7.6 million dollars in grants have been awarded to New Jersey municipalities and school districts since 2009.

2023 IN REVIEW

HIGHLIGHTS

Community Energy Planning: To help municipalities identify energy initiatives to increase clean energy production, reduce energy use and cut greenhouse gas emissions, we created an assessment tool and a wide range of resources to support the New Jersey Board of Public Utilities' Community Energy Grant Program. We worked with 31 municipalities, 16 of which are overburdened, to help them develop a Community Energy Plan. Technical assistance included team building, a review of the municipality's community energy data and help identifying gaps and possible initiatives.

Climate and Resilience Planning: To assist municipalities with efforts to assess and address the impacts of climate change in their communities, we worked with New Jersey Future to develop the Climate Change-Related Hazard Vulnerability Assessment Guide, a first-of-its-kind climate vulnerability assessment practitioner's guide.

New Jersey Community Solar Project Finder: To facilitate greater access to solar energy, we partnered with the New Jersey Board of Public Utilities to create the online New Jersey Community Solar Project Finder that allows New Jersey residents to search by zip code for community solar projects serving their community.

Sustainable and Scalable Food Waste Solutions: To address food waste in K-12 schools, we conducted a comprehensive food waste pilot study of three schools that collectively resulted in a 95% reduction in food waste. The schools composted any food waste generated and diverted 21,300 pounds of unopened food items to share tables. This resulted in the prevention of an equivalent of 207,720 pounds of carbon dioxide entering the atmosphere. A food waste toolkit for K-12 schools was developed and new and revised food waste actions were added to the Sustainable Jersey for Schools certification program. The project partners were Rutgers Cooperative Extension and the New Jersey Department of Environmental Protection.

Trees for Schools: To mitigate climate change and its impacts, we partnered with the New Jersey Department of Environmental Protection and The College of New Jersey to award 23 public school districts, two public charter schools, and nine public colleges and universities \$4.55 million to plant 3,000 trees on campuses across the state.

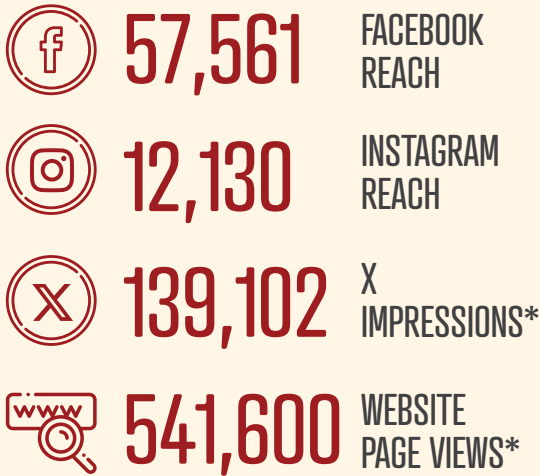

New Jersey Sustainability Summit: Over 500 hundred changemakers gathered at our Sustainability Summit to network, learn and take action. Sustainability exhibitors shared innovative resources and dozens of electric vehicles were displayed at the Electric Vehicle Ride and Drive and Fleet Showcase, including heavy vehicles and buses. Educational sessions focused on expanding the use of renewable energy, transitioning to electric vehicles, making communities more resilient to climate change, ensuring equitable access to resources for all and more.

Partnership to Support Energy Efficiency: We empowered communities to better manage energy use and access energy-efficiency programs and incentives through the Sustainable Jersey-PSE&G Partnership Program. Participating municipalities and schools were provided customized technical assistance and implementation support. Assistance options include Residential Energy Efficiency Outreach Campaign; Technical Assistance for Energy Efficiency in Municipal or School Facilities; and Commercial Energy Efficiency Outreach Campaign.

New Jersey Student Climate Challenge: To empower public high school and middle school students to be climate leaders, we administered the New Jersey Student Climate Challenge. The student teams completed projects that addressed a cause or impact of climate change, such as an educational campaign about the environmental impacts of fast fashion; a demonstration project showing how black soldier fly larvae reduce methane emissions; and the promotion of pollinator gardens to reduce habitat loss caused by climate change. The program partners are the Drumthwacket Foundation and Atlantic City Electric.

Community Equity Pilot: We are working with Dunellen Borough to create a community demographic profile, assess the existing trusted sources for information within the community and develop an equitable municipal communications strategy. This will help the municipality more effectively share critical information with residents while strengthening our new Community Equity Profile priority action. This work is supported by the Emily Hall Tremaine Foundation.

Our Shared Future

Sustainable Jersey will continue to empower New Jersey communities to build a better world for future generations with the tools, training, technical assistance and financial incentives necessary to pursue critical sustainability initiatives. Together we can build resilient communities, tackle climate change, advocate for social justice, preserve our state's natural resources and prepare the next generation to address future challenges.



Supporting Climate Change Education

With funding from the New Jersey Department of Education, we will continue to provide professional development for New Jersey teachers and develop resources to help them implement climate education in their classrooms. We will conduct research to better understand public school teachers' approaches to climate change education, identifying areas requiring additional support to enhance teaching practices. We will expand the New Jersey Climate Change Education Hub by creating new inquiry-based lesson plans specifically designed for New Jersey and in alignment with the New Jersey Climate Education Student Learning Standards. By equipping students with the knowledge and skills needed to understand the climate challenges, we help build the next generation of climate literate leaders, including policymakers, scientists, teachers, entrepreneurs and more, who will develop solutions and lead the green economy.



Focusing on Sustainable Energy

Supporting municipalities and schools to reduce their community carbon footprint is a primary focus. Our targeted outreach and technical assistance will help them more effectively reduce energy use and emissions, increase renewable energy and apply for state and utility incentives for energy upgrades on facilities.



Advancing Equity

Sustainable Jersey continues to strive to become more equitable, more inclusive and better prepared to do the work of advancing social justice while supporting municipalities and schools in New Jersey to do the same. In doing so, our organization commits to take anti-racist action and to oppose oppression in all forms. In 2023, we provided technical assistance to municipalities interested in advancing social equity, diversity and inclusion.

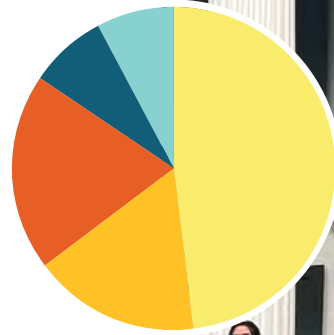

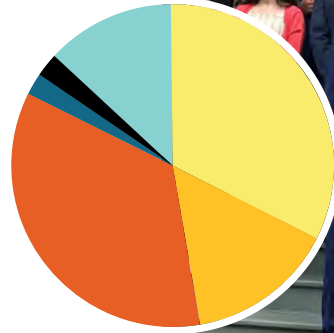
FY2023 FUNCTIONAL EXPENSES

FY2023 REVENUE

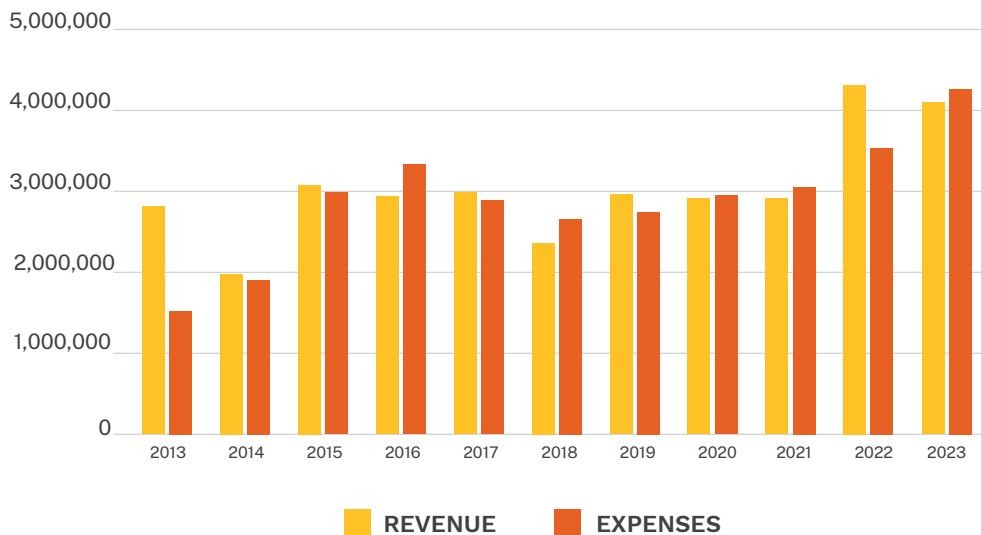
