##### Create Green Team

10 Points

Bronze Required

**Program Summary:** During the November 18, 2013 Council Meeting the Verona Town Council decided to support Verona's participation in the program Sustainable Jersey. In a presentation to the Council introduced by Councilman Kevin Ryan, Verona Environmental Commission (VEC) member Anthony Saltalamacchia described it as "Weight Watchers for the environment": Sustainable Jersey awards points for different pro-environment steps and the more points a town adds up, the better. Each town gets to choose the steps it wants to take, but Sustainable Jersey has materials to guide the town through the steps-and often grant money to lower the cost of doing so. To get started with Sustainable Jersey, the Council needed to adopt a resolution and VEC Chair Gloria Machnowski gave the Council a sample format to follow. Council member Frank Sapienza offered to put it on the agenda and Town Manager Joe Martin scheduled the vote for December. The resolution to join Sustainable Jersey way unanimously approved by all Council members. During the Verona Fair in the Square on December 7th the VEC table was busy all day long with residents of all ages learning about Sustainable Jersey, a free certification program for municipalities that want to go green and save money in the process. Many residents signed up to volunteer in the Green Team to help coordinate Verona's sustainability efforts. Children took the Kid's Green Challenge and everybody got a Sustainable Jersey pin and signed the 2014 Verona Pledge promising to recycle more, save water, eat more veggies, use reusable bags, walk more and drive less. The Council adopted a resolution to create Verona's Green Team on March 17, 2014. Township Media Coordinator Steve Neale was appointed to organize the newly created team and its first formal meeting took place on May 7th at the Verona Community Center. ##### Community Education & Outreach

**Program Summary:** We have taken a lot of steps to make our programs visible and to make online resources our priority in order to get the word out about Sustainability in Verona and NJ. We have created our own Sustainable Verona program with our green team running the program. Sustainable Verona is made up of several municipal employees, including our Recycling Coordinator, head of DPW, Media Coordinator, and a couple councilmen. We also have residents who are involved with businesses in town including, a funeral home which runs on solar, a green architect, a rep from Renewable Energy Inc., the head of our Environmental Commission and members of our Shade Tree Commission. We have our own webpage on the official Township of Verona website, [www.veronanj.org/sustainableverona](http://www.veronanj.org/sustainableverona). This page has information on our green team, programs, local organizations, and a ton of links to useful online resources in the areas of, garbage & recycling, waste reduction, buy fresh buy local, educational

We have fliers up at Verona Town Hall and the Verona Community Center, the most high traffic buildings. These fliers have the link to the webpage. The head of our green team has done interviews with the local newspaper and written press releases about the program as well.

### Fleet Inventory

**Program Summary:** The Township of Verona keeps a full list of all vehicles for every department in town, which is updated yearly. We also keep track of gas usage, broken down monthly by department as well as diesel fuel usage broken down monthly by department. We have our own gas tanks and every vehicle has its own unique key that is used in order to fill up. This allows us to track how much each vehicle is obtaining every time they fill up and that is how we came up with our totals. We have attached an example of this using our Rescue Squad vehicles. In the report it shows the price per gallon as \$1.00 but in reality the price averages out to be \$3.00/gallon. We have some issues when people share these keys making it hard to track through the reports. We see this with the Police Dept. and some DPW vehicles. We have worked very closely with the head of DPW who is also a Green Team member. He helped us fill in this spreadsheet and we plan to make this spreadsheet the standard for our inventory moving forward. We did find that the original fleet list (Entire Verona Fleet) we had was outdated and this new list will become the norm and has been given to the head of insurance as well.

### Municipal Onsite Solar System

10 Points

**Program Summary:** How did Verona Township Go Solar? Spearheaded by Councilmember Jay Sniatkowski, Verona received an initial \$650,000 grant to pursue its solar panel project in 2007. The township was approved for three sites: the wastewater treatment plant, the Verona Community Center and the municipal garage. According to Lab Manager Tim Newton the total project cost \$633,923, and Verona received \$327,802, or 52 % of the cost, in rebates. The Wastewater Treatment Plant It cost \$279,923 to install 170 fixed panels as part of a system rated for generating 33.2 kilowatts per hour. The panels were weighed down instead of bolted to the roof and were fixed in place to capture the maximum amount of light throughout the day. It came online in August 2007. The wastewater treatment plant's pumps use lots of energy, so the township could install more panels at the site. Verona Community Center It cost \$244,000 to set up 154 panels at the Verona Community Center. The 30.8 kilowatt per hour system came online in October 2007. The Township Garage Verona placed 14-kilowatt system of 70 solar panels on the township garage roof for \$110,000. The intent was not to build a solar farm but to reduce energy cost. It began generating power also in October 2007. The panels themselves are rated to generate 195 to 200 watts per hour adding that they weigh 35 to 45 pounds and are essentially maintenance-free. For more information please visit <http://www.veronaec.org/cleanenergy> How Solar Installations Started in Verona? Prout Funeral Home's system is the first solar installation in Verona. The system consists of 114 solar photovoltaic panels on the roof and 6 inverters, for a 17.4 kilowatt system. In a second phase a solar fence (8.28 kilowatt system) was installed. Part of the project was the installation of an educational display in a public area of the Home. Beyond the environmental benefits are the educational opportunities such as tours given to school children from Verona. Prout Funeral Home was recognized as the winner of the 2007 New Jersey Clean EnergySmall Business Leader, a new category for the Clean Energy Leadership Awards. These PSAs and any future publicity from Jersey Fresh will be updated and continue to air indefinitely on our TV station and YouTube channel. More on Morgan's Farm: To get to the farm stand from Pompton Avenue turn right on Commerce Road and turn right at the first entrance. Bear left and follow the winding road to the parking lot. The farm market is open on Saturdays as of May 31 from 9 a.m. to 1 p.m. You can check what's being harvested each week on the Morgan's Farm Web site or use its Facebook page. There is local honey available every weekend. As the crops grow, and the vegetables ripen, each week's supply will vary, but everything is picked fresh between 5 and 6 a.m. each Saturday. In addition to the vegetables, Ostering also sells honey, from a local beekeeper in Cedar Grove, farm-fresh eggs and this week he will have blueberries and corn from New Jersey farms. ### Environmental Commission

**Program Summary:** The Verona Environmental Commission (VEC) was established by Ordinance No. 9-92 on August 3, 1992. Currently the commission has 8 members, its oldest member is 76 years old and its youngest is a 15 year old sophomore student. After identifying places where drivers frequently idle, the VEC petitioned the Town Council to install "No-Idling" signs at five schools and the Verona Community Center. The VEC distributed idling education brochures and created presentations for the local TV. It also organized an annual anti-idling poster contest for elementary and middle school students for the last 5 years. VEC volunteers set up poster exhibits at the schools, the Verona Public Library, in local businesses and on street signs. Winners were recognized at a ceremony in Town Hall, where they received \$50 and a certificate signed by Verona's mayor. During the event the VEC presented its new video created with the posters. ### Community Forestry Management Plan & NJUCF Accreditation

20 Points

**Program Summary:** Our first Community Forestry Management Plan was done in 2008 and we have just been approved again through 2017. As part of the Management Plan a survey of the condition of the Township's trees was done. Also we have a continuing inventory of the Township's trees since 1994, 20 years of data. The Verona Shade Tree Commission assists the township with the care of our public trees. The commission is comprised of volunteers who are residents designated by the Mayor. The current members are Bob Dickison (Chairman), Bob Prout, Gloria Starita, Robert Boeck, Sandra Borland. We contacted NJ Forester Alec McCartney about Verona's tree canopy and we are at 61.8% for developed land. This was taken from the 2009 Urban & Community Forests of the Mid-Atlantic Region book by David Nowak and Eric Greenfield- NRS-47. We will try to maintain a 50% canopy. We have added everything we have for the CEU documentation as of right now. These docs show that we do have the required number of CEUs needed to switch our status to approved. We have had a hard time receiving the official documentation needed from the state after many attempts, which has proved frustrating. We will be happy to provide all the proper documentation as soon as we receive it.

## Tree Planting Programs

10 Points

**Program Summary:** Verona Township will be planting about 50 replacement trees in 2014, mostly this spring. We keep an on going list of replacement trees that need to be planted. This is part of our inventor system. Planting locations are determined by the Shade Tree Commission and our Shade Tree Ordinance. The commission is comprised of volunteers appointed by the Mayor. The currents members are Bob Dickison (Chairman), Bob Prout, Gloria Starita, Robert Boeck, Sandra Borland. Verona Council Member Kevin Ryan is the commission's liaison. Public meetings are held monthly in the Municipal Building. More information can be found here: [www.veronanj.org/boards/shadetree](http://www.veronanj.org/boards/shadetree) and [www.veronaec.org/township-trees](http://www.veronaec.org/township-trees). In addition, in 2014 many more trees will be planted by Verona volunteers under the guidance of the Verona Environmental Commission, the Hilltop Conservancy and local school's groups such as the H.B. Whitehorne's Beautification Committee. The VEC ([www.veronaec.org](http://www.veronaec.org)) continues its restoration of the Peckman River woods behind F.N. Brown school, removing invasive species and adding swamp white oaks, river birches, serviceberries and other native plantings. About 80 local volunteers participated in their April and May events. During May and June the Hilltop Conservancy ([www.hilltopconservancy.org](http://www.hilltopconservancy.org)) is in the process of planting 100 native trees and shrubs at the Hilltop Reservation. Because of the poor soil quality, volunteers had to apply compost in each planting hole and install fences to protect trees from deer. The Verona Department of Public Works assisted both projects. HBW Beautification Committee planted six trees and other plants in the last 2 years. This summer, several school families have volunteered to water and weed. Also, the VEC has a Treasured Tree program that recognizes beautiful, mature trees and the homeowners who care for them. ## Tree Protection Ordinance

10 Points

**Program Summary:** The Borough of Verona finds that the unregulated and uncontrolled destruction and removal of trees upon lots and tracts of lands within the Borough of Verona has resulted in increased soil erosion, has decreased fertility of the soil, has created dust and mosquito breeding places, has caused depreciation in property values and has impaired the stability and value of real estate, with the result that there has been and will be in the future a detriment to the public health and welfare which requires the passage of this chapter. ### Grass - Cut It and Leave It Program

**Program Summary:** To promote a successful Cut It and Leave It Program we have developed a full brochure explaining the benefits in detail and how to properly Cut It and Leave It. This brochure is available as a hard copy at our Town Hall building, the DPW building, where the bags for the clippings are sold to residents and at the Verona Community Center. Landscapers have to pay a low cost fee in order to use our dump. This fee is also paid at the DPW building, making it readily available to all the landscapers as well as the public. We have also added a brief description of the program on our Sustainable Verona webpage, [www.veronanj.org/sustainableverona](http://www.veronanj.org/sustainableverona) as well as a downloadable version of the brochure. We have also developed a slide that will air on our local TV station VeronaTV during the regular bulletin. This slide and brochure will also be publicized through our Sustainable Verona Facebook and Twitter pages. ### Reusable Bag Education Program

5 Points

**Program Summary:** Reusable Shopping Bags Since 2012 Verona Township and the VEC encourage residents to use reusable shopping bags. Why choose reusable shopping bags instead of paper or plastic bags? Because manufacturing paper and plastic bags require tremendous amounts of natural resources and energy. Plastic bags are typically made from oil, this accounts for about four percent of the annual oil production. The biggest energy input to make a plastic bag is electricity, which mainly comes from coal-burning power plants. According to the EPA we use 100 billion plastic bags in the U.S.A. each year, while the overall plastics recycling rate is only 8 percent. How does plastic bag recycling work? Recycling involves re-melting the bags and re-casting the plastic. Manufacturing new plastic from recycled plastic requires two-thirds of the energy used in virgin plastic manufacturing. Please reuse the plastic bags you already have and then bring them to your local supermarket collection bin to be recycled. Over 100,000 birds and marine life die each year due to an encounter with plastic debris; including whales, seals and turtles. Plastic bags last about 500 years and cause great damage to the environment. Brown paper bags come from trees. In the U.S.A. approximately 14 million trees were cut down to produce 10 billion paper bags annually. Where do paper bags go when you're done with them? If you compost them, the bags decompose in a couple of months. If you place them in your trash they are burned in a incinerator. If you choose to recycle them, the paper must be re-pulped by a chemical process with bleach to separate the pulp fibers. The fibers are then cleaned and washed to remove ink before being pressed into paper again. Neither paper nor plastic disposable bags are the best choice. Choosing reusable canvas bags and using them over and over is the way to go! The commission distributes canvas bags and informs the public about its benefits at the Verona Recycling Center. The Verona Environmental Commission also brings games to schools and fairs to educate kids and parents about "which bag is the most sustainable one" to encourage the use of canvas bags instead of plastic or paper (see 2014 Bag Game picture).

### Recycling Depot

10 Points

**Program Summary:** The Verona Recycling Center was created along with Cedar Grove's Recycling Center, in the early 1980's. Back then, as a member of the Kiwanis Club, the High School Key Club of Cedar Grove had a project of collecting newspapers, as a fund raiser. From this project, the Cedar Grove Recycling Center, was born. At that point, Verona resident Marc Kaplan approached the Mayor and Council to create a Recycling Center in Verona. Later on he became a member of the Verona Environmental Commission. The recycling depot was established at 10 Commerce Court in Verona and it is currently open 8:30 am to 3:30 pm, Wednesdays and Saturdays. The Supervisor is Mike Inglesino. You can watch the 2014 HD video "Verona Recycling 101" here: <https://www.youtube.com/watch?v=LJAYVXjiej4> - Originally the Recycling Center was just concrete bins. It evolved to the present day configuration, with roll-off containers. Currently almost 35% of the waste collected in Verona is recycled, which helps to cap our garbage costs. The 2,500 tons of recyclables toted up in 2008 saved taxpayers more than \$193,000 in disposal costs. The following materials are accepted at the Verona Recycling Center: Commingled Materials: Glass Bottles, Tin and Aluminum Cans, Plastic Bottles and Containers -Type #1, #2 and #5 except Gasoline and Chemical containers. Corrugated Cardboard. E-Waste: TVs, computer monitors, printers, etc. White Goods/Metal items such as bicycles, air conditioners and file cabinets. Motor Oil and antifreeze. Mixed paper: including newspaper, white office & computer paper, telephone books and all Chipboard such as Cereal Boxes. Propane Tanks: empty and dispose at the center after receiving a permit from Public Works Office. There is also a clothing and shoe collection container for donations.

## Prescription Drug Safety & Disposal

10 Points

**Program Summary:** Twice a year the Verona Police Department in partnership with the Drug Enforcement Administration (DEA) give Verona residents another opportunity to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. Residents are invited to bring their pills for disposal to the Town Hall lobby at 600 Bloomfield Avenue in Verona. The service is free and anonymous, no questions asked. The upcoming collection in Verona is scheduled for April 26 between 10 AM and 2 PM. During 2013 the Verona Police Department collected unwanted medicines on April 13 and on October 13, at the same place and times. Hand outs were provided from the VMAC committee. The Verona Municipal Alliance Committee (VMAC) provides educational programming and prevention outreach to the citizens of Verona. Posters were placed around town with location, times and dates to promote the event. The estimated number of persons served was between 40 and 50 each time. The approximate number of prescriptions collected was 45. The total weight was 65 pounds in April and 48 pounds in October. Collected prescriptions were brought to the Essex County Police Academy and turned over to the DEA who weighted them and took them for destruction. This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—both pose potential safety and health hazards.
