Program Summary: Gloucester Township supports responsible pet ownership in the community. We have taken initiative to protect the well being of the animals in the community. We hold a dog census every two years, have an animal control officer, perform K-9 demonstrations, pet licensing, we advertise AWA trap and release for feral cats, and we have a rabies clinic. The township is committed to making the community an ideal home for companion animals.

Program Summary: Gloucester Township's sustainability outreach program encompasses many areas and involves many forms of communication with residents. The Green Team utilizes several different forms of media in cooperation with the township to connect to members of our community. For example, through a community notification known as Nixle, the township website, social media such as Facebook and Twitter, e-newsletters, the two digital marquees around the township, paper flyer inserts in our tax bills, through a newsletter mailed to residents three times a year. The Green Team also has a challenge where community members are tasked with taking our pledge and supporting the environment. Additionally, the Junior Police Academy supports healthy, nutritious and active lifestyles for the youth of our township. Each year, the township participates in National Night Out to promote safety and community fostering activities in our neighborhoods. This year's Earth Day event was a huge success for the Green Team at the historic Gabreil Daveis Tavern. Young people were very involved during our Earth Day event where the Community Garden was prepped for the upcoming year; our Green Team also gave a lecture and demonstration about composting, and provided a healthy snack promoting the importance of healthy eating. We have held Natural Trail Walks and Rain Barrel Workshops, and begun work on a Greenhouse within the township, and community gardens. The township has a Business Breakfast yearly and a new award supporting the efforts of the Green Team was introduced to the first winner of the Green Business Award. Furthermore, the township prides itself on promoting the importance of recycling during the Community Paper Shredding event.

Program Summary: Gloucester Township's Green Challenge encourages the community's households to participate in a pledge consisting of four different actions with the goal of simple lifestyle changes that can have a big impact on our environment. Young individuals volunteered their time during our fair to ask people to take the pledge and collect signatures. We currently have 939 people who have risen to the occasion and took the pledge. Program Summary: The Green Fair held by Gloucester Township was a significant part of our annual "Gloucester Township Day" on June 7th, 2014. Advertised on our website prior to the event, the Green Fair marks a strong commitment to green initiatives. The fair was the product of months of planning, culminating in a very successful and informative event. The Mayor & Council booth were part of the Green Team's tent, showing the commitment that the municipality has in supporting the Green Team. The event was held on the grass in our park, using natural sunlight and reducing emissions associated with the use of an indoor facility. Those in attendance had been encouraged to walk, bicycle, or carpool to the event and to apply that advice to their everyday lives when possible. The Green Team of our Sustainable Gloucester Township initiative had a booth and ensured that plenty of recycle bins were present at the event, showing through example how crucial recycling is to our sustainability measures. Participants and vendors alike were strongly encouraged to recycle. Outside businesses and organizations took part in the event as well, and all vendors were encouraged to recycle any waste if possible. The fair advertised the popular Blackwood Farmers Market, promoting the patronization of local businesses and the fresh produce sold at the market. Additionally, used footwear was collected for Soles 4 Souls to give to the needy and to prevent them from being discarded in landfills. Throughout the day, we asked participants to take the Green Team Challenge and pledge to alter their impact on the environment in a positive way. Basil seeds and reusable canvas bags were distributed to the crowd at the Green Team booth. The Green Team displayed the winners of the Sustainable Gloucester Township Photo Contest, had a rain barrel at sight and discussed the importance of rain barrels. They then held a raffle to win the rain barrel at the end of the fair. The Green Team also had a raffle for a free plot in the Gloucester Township Community Garden. The Green team was on hand at their booth to answer environmental questions and gave out information on what is happening in Gloucester Township

Program Summary: The Green Fair hosted during our Annual Gloucester Township Day on June 7,2014, promoted sustainable lifestyles by giving participants tips and resources to help them "green" their daily routine. However, the Green Fair also led by example, following its own Green advice in the ways it was advertised and organized. Prior to the event, Gloucester Township focused on advertisements that used as little paper as possible in order to reduce waste. Gloucester Township Day's Green Fair was publicized via the township website, e-newsletters, and both township marquees. Participants were encouraged to walk, bike, or carpool to the event in an effort to reduce carbon emissions associated with transportation. Other sources of emission and energy output were minimized by holding the green fair outdoors in our very own park, utilizing natural lighting and eliminating the need for air conditioning. The green fair hosted local businesses, that each showcased their own green products and practices. Vendors were sent a letter early on in the year addressing the encouragement of greener practices. Vendors posted

signage promoting recycling while simultaneously discouraging the use of non-recyclable give-aways. Event organizers provided plenty of recycling receptacles at the event that were both accessible and clearly marked. Serving as a model to the community, these organizers used signage from past Gloucester Township Days that can be used for years to come, helping to ensure that our Township remains a great place to live, work and play. The Green Team handed out reusable shopping bags and basil seeds. They were on hand to answer questions and hand out information about the environment, sustainability and what is happening in Gloucester Township. They held rain barrel informational sessions and raffled the rain barrel off at the end of the fair. They displayed the winners of the Sustainable Gloucester Township Photo Contest, in which they had to capture the beauty of summer and winter in Gloucester Township.

It was a collaborative effort of the public works, Gloucester Township Police Department, the mayors secretary and chair of the green team. We compiled information from public works and our police department and inputted it into the spreadsheet. We compared the information gathered this year to last year's fleet inventory. With the rising costs of fuel the township seriously considers purchasing alternative fuel vehicles and has already purchased several electric, natural gas, or flex fuel vehicles. Through this project we keep track of our vehicles more efficiently. In doing this it will help us to keep track of operating costs and improve our purchasing of energy efficiency vehicles.

Municipal Onsite Solar System

Program Summary: Beginning in 2011, the Gloucester Township Municipal Building has been utilizing the natural energy from the sun as power. Funded in part through the Energy Efficiency Block Grant, the municipality was able to construct solar panels on top of the building's roof which allowed municipal land to remain unaltered. Plans are also underway for the local school boards to also install solar power for almost all of the school buildings, as well as the Department of Public Works building. A kiosk displays information about how the panels work and how much power has been generated to date. Residents of Gloucester Township were informed via numerous ways including an article in the township newsletter and through news outlets. The future looks very bright for Gloucester Township.

Community Gardens

Program Summary: The Gloucester Township Community Garden is located across the driveway from one of the Township's historic houses, the Gabreil Daveis Tavern. The garden formally opened the first week of June 2011. In 2014 the Green Team doubled its size. It boasts 41 plots, a common herb garden, and a common raspberry patch. We are building a patio and pergola for a gardeners' meeting space. A fee to cover water usage expenses of \$25 is charged for plots depending on size. The Community Garden opened for its third year after the Township's Earth Day event which included a clean-up at the garden. The garden's weeds were put to compost. The paths were mulched with mulch that the Township makes from the curbside pickup of yard waste. During the Earth Day event, a small composter was installed in the garden and its use was demonstrated to the residents in attendance. The common plots were also weeded after a lesson on what were weeds and what are returning herbs and raspberry plants. Runners from the raspberry bushes were transplanted to extend the raspberry patch. Gardeners are encouraged to practice organic methods of farming and determent of small animals. Each gardener maintains their own plot as well as the watering needs. The gardeners have already been harvesting a wide assortment of crops: beans, zucchini, peppers, tomatoes, basil, eggplant, and cucumbers while waiting for others- cantaloupe, watermelon, and pumpkins. The Gloucester Township Energy Master Plan consists of solar projects, energy audits, energy purchase consortiums and recycling initiatives. In 2011, Gloucester Township received their first Energy Master Plan ("EMP"). Within the EMP, it describes the current state of the Township's energy usage as well as short-term and a long-term plan on how to decrease its energy consumption and increase its clean energy production, overall reducing the Township's carbon footprint. There are six detailed sections within the EMP covering the assessment of the Township facilities, assessment of Township owned properties, Clean Energy Capital Projects, Energy Procurement, Clean Energy Production and lastly Capital Financing for Clean Energy Projects. These sections will help guide the Township to become not just a participant in Sustainability but to be a leader and an example when it comes to Clean Energy. Program Summary: Sustainable Gloucester Township is very excited to announce initiatives in Gloucester Township that support local businesses in our community. There are many different ways that Gloucester Township supports the local economy. The Economic Development Corporation hosts a Business Breakfast each year to recognize local businesses for their support

Program Summary: Sustainable Gloucester Township held our first Rain Barrel Workshop with a focus on educating our community about water conservation through innovative methods. In order to achieve this goal our Green Team held a meeting to organize the Rain Barrel Workshop. This program was advertised on our municipal website, municipal electronic marquees, at the Gloucester Township Day Green Team booth, through email newsletters and on a local cable channel. In this workshop participants learned what a rain barrel is, how to make a rain barrel, and how participants can use the rain barrel for daily use. Materials to craft the rain barrel were purchased by each participant and a hands-on rain barrel construction demonstration was given. Our workshop was sponsored by the Gloucester Township Community Impact Council, AmeriCorps NJ Watershed Ambassador Program and the Rutgers Cooperative Extension of Camden County. Our first workshop was held on June 25, 2011. We collected evaluation sheets on the day of our workshop and will use the feedback from participants to improve and enhance our future workshops. Recycling Depot

Program Summary: Gloucester Township prides itself upon the level of service it provides to the members of the community. Gloucester Township provides a Recycling Depot for that which cannot be collected curbside. Located at the Township's Public Works building and at the GTMUA, the Recycling Depots are the destinations for all residents who seek an environmentally-conscious way to recycle uncommon types of waste. The Depot takes refrigerators, freezers, air conditioners, motor oil, anti-freeze, car batteries, concrete, brick, rubble, and electronics. It is located at 1729 Erial Rd. and the yard is open from 8 am until 4 pm for drop-off. Approximately 4,000 people drop off items at our recycling depot annually. The township also has a new drop-off location for materials which are collected throughout the municipality at curb-side. The GTMUA building is located at 71 Landing Rd. and now accepts glass, metal, plastic, paper and cardboard at a drop-off location for excess recyclables which did not fit in the resident's recycling bin. Gloucester Township also has a third option for residents looking to dispose of special waste to be recycled. The County of Camden holds special drop-off dates at Camden County College which is located within our township. Which collects hazardous wastes such as oil-based paints, solvents, thinners, pesticides, herbicides, gasoline, kerosene, polishes, brake fluid, transmission fluid, pool chemicals and cleaning fluids, etc. Additionally, Gloucester Township has a great curbside pick-up program for recyclable materials. One of the functions of the Gloucester Township Municipal Utilities Authority (GTMUA) is the operation of the Township's Recycling Program, through which GTMUA employees collect recyclable material such as glass, metal, plastic and paper, as well as biodegradable materials such as grass and leaves. In 2012 the GTMUA began accepting these same materials at a drop-off location at the GTMUA building for residents who have excess recyclables. Gloucester Township has a great recycling program which was further improved at the end of 2011 with our Single-Stream recycling program. Residents throughout the township also received new recycling bins which are much larger than the previous cans and allows residents to co-mingle all curbside materials, which has greatly increased recycling among households. This information is listed on the township website, glotwp.com, and is also published annually in a newsletter that goes out to all residents of the township. Such active community

interest and participation in sustainable measures such as special materials recycling demonstrate a growing awareness of environmental initiatives in Gloucester Township. In 2014 the Township came out with TV Videos and youtube videos to educate residents. The Mayor also did a video for children to show in Gloucester Township Schools and a coloring book is in the works to go alongside the video. Since then the township has collected over 700 pounds of medicinal waste in cooperation with the DEA from our 65,000 residents. The police department puts out numerous emails and the two drop off locations are in the foyer entrances to the municipal building, very prominent locations. The Gloucester Township police department sends out community bulletins about keeping prescription drugs out of the hands of teens. Every 4th grade student in Gloucester Township has a lesson on the dangers of prescription drugs. This is part of the Society Improvement Program. (SIP)
