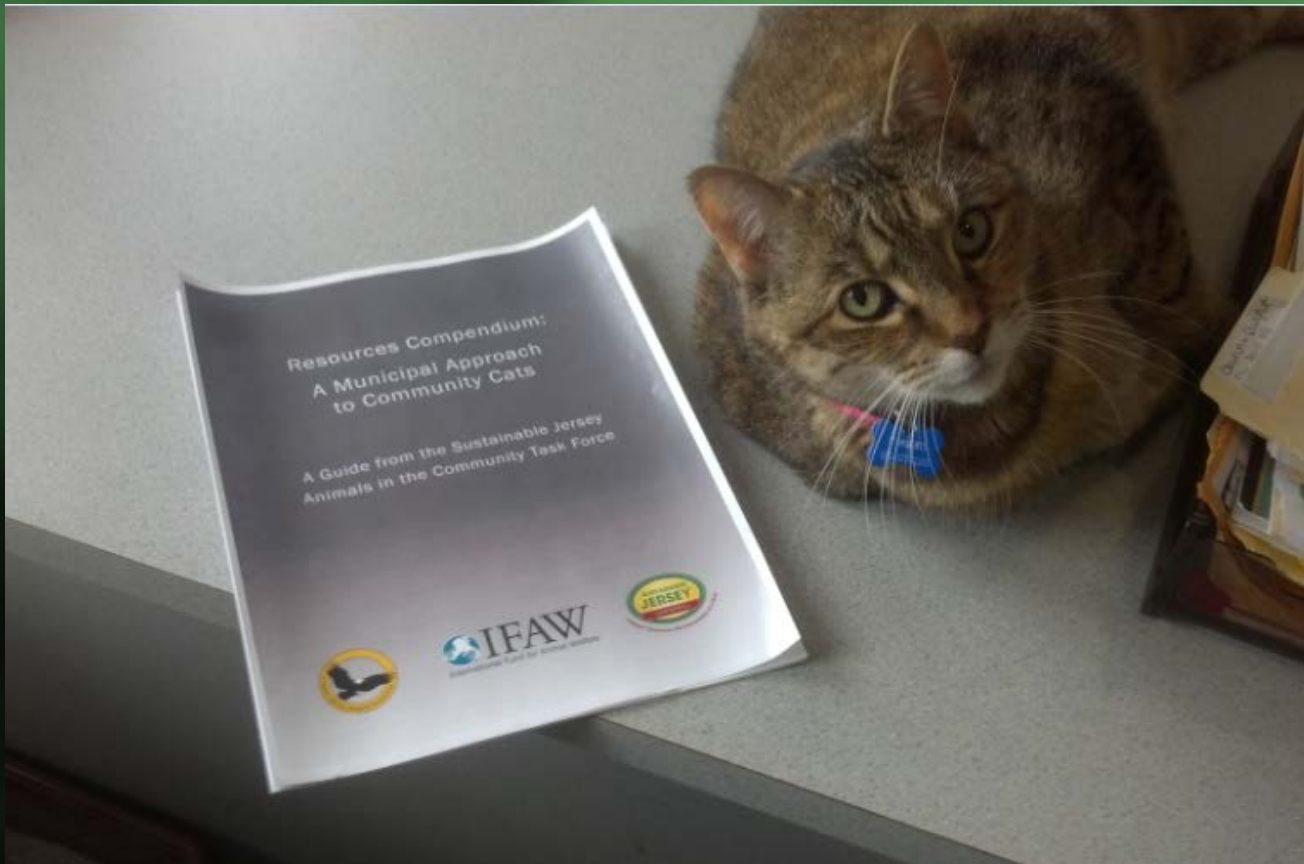
- A collection of concise but detailed information about a particular subject, especially in a book or other publication.
