A. Background

Sustainable Jersey is partnering with the [Environmental Defense Fund \(EDF\)](#) and [New Jersey Natural Gas \(NJNG\)](#) on the [Climate Corps Program](#) to assist municipalities and school districts within [NJNG service territory](#). The program provides direct technical assistance at no cost to school districts and municipalities to improve building performance through energy efficiency analysis, planning, and upgrades.

A trained EDF Fellow, typically an MBA or similar graduate with in-depth training in energy project assessment and development, will work with municipalities and school districts for approximately 9-10 weeks during the summer of 2020. Due to the COVID-19 pandemic, the Fellows will work remotely. Participating municipalities and schools should be prepared to support collaborative work in an on-line work environment, including providing key information such as utility data.

EDF Fellows provide expertise and support for school districts and municipalities to take advantage of utility and [New Jersey's Clean Energy Program \(NJCEP\)](#) incentives for energy efficiency audits and for facility and/or equipment upgrades that can help save energy and money.

EDF Fellows in this program in previous years have helped school districts and municipalities to:

1. Submit documentation for [Sustainable Jersey energy actions](#), including but not limited to:
 - Energy Tracking and Management (including Benchmarking)
 - Municipal or School Carbon Footprint
 - Energy Efficiency for Municipal and School Facilities
 - Fleet Inventory

2. Prepare documentation to submit applications for NJCEP programs such as Local Government Energy Audit, Direct Install, and SmartStart as well as to assist in preparing grant applications (such as for the Sustainable Jersey Grants Program or NJDEP's It Pays to Plug In program).

The exact work program for each school district or municipality will depend on the energy work that has already been completed, as well as district or municipality priorities for building energy upgrades. The EDF Fellows work with Sustainable Jersey staff and are compensated through a grant funded by New Jersey Natural Gas. The selected municipality(ies) and school district(s) will be expected to provide:

- Dedicated staff to serve as supervisor/coach and as the primary contact for the Fellow and provide oversight of the Fellow's work, in collaboration with Sustainable Jersey energy program staff.
- Access to utility bills and other energy records as needed for the project, support from relevant staff, and an opportunity to present project results and recommendations to senior decision makers by the end of the program.
 - IMPORTANT NOTE: Due to the remote online work environment for the 2020 program, the school district or municipality must be able to provide access to 14 consecutive months of utility billing information to the Fellow electronically. This can be via scanned utility bills or other electronic resources, such as an excel spreadsheet. The EDF Fellow will assist the school district or municipality with this process.

B. Eligibility Requirements

To be eligible to apply for the 2020 EDF Fellow program, an applicant must:

- Be a New Jersey municipality or school district registered in the Sustainable Jersey or Sustainable Jersey for Schools certification program.
- Be physically located within the [New Jersey Natural Gas territory](#). See [Section F](#). for a list of municipalities served by NJNG.
- Agree to provide the support for the EDF Fellow as outlined in [Section A](#). above.

In order to apply, an applicant must first **sign up** for an application. This is true for both new applicants and for those who have previously applied for an EDF Fellow. This platform is also used for applications for the Grants Program—applicants that previously applied for grants through this platform must also sign up for an application. Accounts created on this platform do **not** carry over and are not connected to Sustainable Jersey/Sustainable Jersey for schools certification accounts.

Additionally, if an entity is submitting proposals for **multiple Sustainable Jersey Grant opportunities**, the entity must sign up for an application for each proposal **using a different email address**. For example, if a consultant is in charge of submitting an application for more than one municipality or school district, then the consultant must use a different email to sign up for each application.

You may save your work, log out, and resume your in-progress application at any time by using the login feature. However, once submitted, you will no longer be able to access the application or make any changes. Drafts of the application will automatically save every 5 minutes and a "save draft" button is available at the end of the application form. It is encouraged to save manually using the button often.

Once the application email is submitted, a confirmation email will be sent. If you do not receive this confirmation email, contact grants@sustainablejersey.com to determine if we have received your application.

D. Selection Process

A committee of Sustainable Jersey staff will review and evaluate applications. **During the selection process, it is likely that staff will want to interview appropriate municipal/school personnel to**

assess a potential match with the EDF Fellows program. Applicants must be responsive to this interview request to be considered for the program.

Applications will be screened based on the Eligibility Requirements outlined in [Section B.](#) and evaluated based on the criteria outlined below:

- Responsiveness to selection committee interview request.
- Demonstrated commitment to support the Fellow's effort and complete the appropriate energy actions.
- Commitment to provide 14 consecutive months of utility billing data for the Fellow via electronic means (scans of utility bills or via excel spreadsheet).

If selected to host an EDF Fellow in 2020, the staff contacts listed on this application will be expected to join an introductory conference call with the Fellow in May. These calls are generally brief, lasting under an hour, but help to orient both the on-site staff and the EDF Fellow to the current status of recent and planned energy projects for the duration of the program.

The application will request information on the preferred availability of the application contacts to participate in both the screening and the introductory calls. Sustainable Jersey energy program staff will try to accommodate availability requests when scheduling the calls.

2. Application Contacts

- **Contact information including name, title, mailing address, email address, and phone numbers will be requested for a primary and secondary staff contact.** All contacts will be notified once a final decision on the grant application is made.
- Please provide staff availability for an interview call with Sustainable Jersey's energy program staff in April and a potential introductory call with Sustainable Jersey's energy program staff and the EDF Fellow in May. Introductory calls are only for those selected to participate in the opportunity.

3. Proposal

- **Summary of Completed Energy Initiatives:** Please provide a summary of the energy initiatives that have been completed at any of the buildings listed in the applicant information section. Note if efforts were funded in part through [NJNG](#) and/or [New Jersey's Clean Energy Program](#) (NJCEP) incentives or other external funding sources.
- **Description of Proposed Energy Projects for 2020:** Please provide a brief description of projects for which the support of an EDF Fellow would be utilized. EDF Fellows work

primarily on energy efficiency upgrade projects for buildings. The EDF Fellow can prepare applications for [NJNG](#) and/or [NJCEP](#) funding incentives.
