Sustainable Jersey Celebrates a Decade of Impact: To celebrate Sustainable Jersey's tenth anniversary, we are spotlighting the people, organizations, businesses and agencies that have been a part of our evolution. Sustainable Jersey is thankful for our valuable partners at the Metropolitan Planning Organizations (MPOs) and the New Jersey Transportation Management Associations (TMAAs) and would like to acknowledge the role the talented staff at these organizations have on Sustainable Jersey Task Forces. They contribute their time and expertise to help New Jersey municipalities and schools achieve their sustainability goals. For the past ten years, these organizations have provided data, completed research, offered expert policy advice and partnered with Sustainable Jersey and Sustainable Jersey for Schools on important initiatives, events and project to make New Jersey more sustainable.

METROPOLITAN PLANNING ORGANIZATIONS are federally mandated and funded transportation planning agencies made up of representatives from local government and key transportation agencies. Sustainable Jersey works closely with the staff from the three New Jersey MPOs: the North Jersey Transportation Planning Authority (NJTPA), the South Jersey Transportation Planning Organization and the Delaware Valley Regional Planning Corporation (DVRPC). In addition, Sustainable Jersey coordinates with the Alan M. Voorhees Transportation Center located within the Edward J. Bloustein School of Planning and Public Policy at Rutgers University.

North Jersey Transportation Planning Authority (NJTPA) is the federally authorized MPO for 6.7 million people in the 13-county northern New Jersey region (Bergen, Essex, Hudson, Hunterdon, Middlesex, Monmouth, Morris, Ocean, Passaic, Somerset, Sussex, Union and Warren). Each year, the NJTPA oversees over \$2 billion in transportation improvement projects and provides a forum for interagency cooperation and public input. The organization also sponsors and conducts studies, assists county planning agencies and monitors compliance with national air quality goals. Ultimately, all projects that use federal transportation dollars must be planned and approved through the NJTPA. NJTPA staff serve on Sustainable Jersey Task Forces, assist with policy questions and speak at events. Sustainable Jersey partners with NJTPA on the Complete Streets Technical Assistance Program. The towns selected to receive technical assistance get valuable hands-on guidance to move their projects forward. This important work contributes to our mission to create a more sustainable New Jersey. Sustainable Jersey has been fortunate to work with Jeff Perlman, the NJTPA Director of Environmental and Sustainability Planning; Douglas Greenfeld, the NJTPA Manager of Sustainability and Plan Development; Jennifer Fogliano, a NJTPA Principal Planner for Environmental Planning and Mary Ameen, the NJTPA Executive Director. South Jersey Transportation Planning Organization (SJTPO) is the MPO covering Atlantic, Cape May, Cumberland and Salem counties in southern New Jersey. SJTPO serves as a technical resource, provides access to funding and works to provide a regional approach to address transportation planning and engineering issues. SJTPO coordinates the

planning activities of participating agencies and gives a forum for cooperative decision-making among state and local officials, transit operators and the public. In addition, the SJTPO adopts long-range plans to guide transportation investment decisions and maintains the eligibility of its member agencies to receive state and federal transportation funds for planning, capital improvements and operations. SJTPO staff serve on Sustainable Jersey task forces, assist with policy questions and speak at events. Sustainable Jersey partners with SJTPO on the Complete Streets Technical Assistance Program. Alan Huff, the program manager for SJTPO Safety Initiatives and Public Outreach serves on the Sustainable Jersey Land Use and Transportation Task Force and Jennifer Marandino, P.E., SJTPO's Executive Director manages the partnership with Sustainable Jersey on Complete Streets. Delaware Valley Regional Planning Commission (DVRPC) is the federally designated MPO for a diverse nine-county region in two states (Burlington, Camden, Gloucester and Mercer in New Jersey; and Bucks, Chester, Delaware, Montgomery and Philadelphia in Pennsylvania). As an MPO, DVRPC is responsible for planning and approving all projects that use federal transportation dollars by providing forums for cooperative decision-making among its member governments. In addition, as a regional planning commission, DVRPC provides environmental, community and economic development planning for its constituents, and is a resource for regional data. DVRPC regularly convenes a diverse array of partners to increase mobility choices, protect and preserve natural resources and build sustainable, equitable and livable communities that foster greater opportunities for all. DVRPC also provides subsidized professional planning services to New Jersey municipalities, completing dozens of environmental resource inventories, open space plans, farmland preservation plans and other environmental plans in communities across South Jersey. DVRPC staff serve on multiple Sustainable Jersey task forces, assist with policy questions and speak at events. Sustainable Jersey benefits from its collaboration with Chris Linn, AICP, Manager of the Office of Environmental Planning and Rob Graff, Manager of the Office of Energy and Climate Change Initiatives, who helped establish and continue to serve on the Sustainable Jersey Climate Adaptation Task Force. Alan M. Voorhees Transportation Center (VTC) is a leader in transportation research and education at the national, state and regional level and the center of transportation-related training and education, policy and research at Rutgers University. Located within the Edward J. Bloustein School of Planning and Public Policy, the Center brings the resources of a major research university on transportation issues of regional and national significance. Sustainable Jersey is supported by our VTC colleagues who review Sustainable Jersey actions, provide guidance on policy issues and speak at events.



Leigh Ann Von Hagen, AICP, PP is a Senior Researcher and Adjunct Professor at VTC and a founder of the Planning Healthy Communities Initiative at the Edward J. Bloustein School of Planning and Public Policy. Von Hagen manages the NJ Department of Transportation's Safe Routes to School Resource Center and the statewide School Crossing Guard Training program. In addition to her participation in the original development of Sustainable Jersey, Von Hagen was instrumental in launching several statewide health, safety and environmental initiatives including Planning Healthy Communities Initiative, Safe Routes to School, Mayors Wellness Campaign and Shaping NJ.

Trish Sanchez is a Public Engagement and Outreach Specialist and Project Coordinator at VTC who manages, along with the New Jersey Safe Routes to School (SRTS) Project Manager Sean Meehan, the New Jersey SRTS Resource Center. The center, in conjunction with the New Jersey Department of Transportation (NJDOT), provides services, training, coordination, research and technical assistance to the eight TMAs. Miriam Salerno, a VTC Senior Public Relations and Outreach Specialist who works

closely with Sustainable Jersey in her capacity with [Together North Jersey](#) said, “The Sustainable Jersey program is a great example of engagement, collaboration and action to advance sustainability planning at the local level. TRANSPORTATION MANAGEMENT ASSOCIATIONS

There are eight Transportation Management Associations (TMAs) that cover New Jersey’s 21 counties by providing commute options such as carpooling, vanpooling, mass transit, biking and walking. TMAs are non-profit organizations tasked with implementing strategies and programs that address traffic congestion, economic development, air quality and livability issues. Sustainable Jersey municipalities and schools throughout the state get support from their TMA. TMAs assist by providing free programs that align with certification categories including transportation fairs, onsite bicycle and pedestrian safety programs for children and adults, anti-idling awareness campaigns and complete streets programs.

Cross County Connection TMA provides transportation-related services in New Jersey’s seven southern counties, including the counties of Atlantic, Burlington, Camden, Cape May, Cumberland, Gloucester and Salem. Cross County Connection works to provide solutions to complex transportation problems for counties, municipalities, employers and commuters. Patrick Farley, a Land Use and Transportation Specialist at Cross County Connection is helping to revise the Sustainable Jersey “[Complete Streets Policy actions](#)” and oversees the Sustainable Jersey bicycle and pedestrian program updates. Eric Derer, an Associate Transportation Specialist for Cross County Connection, has provided research on ordinances for complete streets to contribute to the development of the action updates. Jason Simmons, a Transportation Specialist at Cross County Connection is the Sustainable Jersey liaison for municipalities and schools that request assistance with the Sustainable Jersey certification application. goHunterdon promotes sustainable transportation in Hunterdon County by working with commuters, employers and communities. For over 20 years, Tara Shepherd has served as the Executive Director and has supported the work of Sustainable Jersey for the past ten years. goHunterdon provides, through its [Sustainable Hunterdon](#) initiative, assistance to municipalities and schools in Hunterdon County in completing various Sustainable Jersey actions. The free assistance includes facilitation of green teams, identification of appropriate action items, implementation, certification submission review and help with grant applications. Nathan Charron, the goHunterdon Environmental Education Coordinator, said, “The Sustainable Jersey program provides the perfect framework for our assistance. A lot of what we do dovetails with the program and creates an entry point for meeting and then assisting towns and schools with these important environmental actions.” Charron is on the Sustainable Jersey Land Use and Transportation Task Force and has worked with many municipalities to document Safe Routes to School efforts to help them gain Sustainable Jersey points toward certification. TransOptions delivers programs and services that improve mobility, the environment and overall quality of life in northwestern New Jersey, specifically Morris, Sussex, Warren and western portions of Passaic and Essex counties. In addition to helping people find alternative commute options, the organization also offers programs in bicycle, pedestrian and teen driver safety as well as


