### 2016 Community Stewardship Incentive Grant Program

The NJDEP Community Forestry Program is proud to announce the release of \$2.3 million dollars in grant funding through the 2016 Community Stewardship Incentive Grant program. Funding is available for three types of municipal tree projects: tree resiliency planning, tree hazard mitigation activities; and reforestation and tree planting projects. ### Green Communities Grant Application

Communities that need assistance in creating a Community Forestry Management Plan (CFMP) are eligible for the Green Communities Grant. The grant is offered every year for municipalities and counties. Currently the grants are up to \$3,000 with a 100% match, that can be made of in-kind and volunteer hours at the federal volunteer rate. For more information visit their [website](#).

### Does Your Municipality Need Technical Assistance with Energy Related Initiatives?

Sustainable Jersey is partnering with the Environmental Defense Fund (EDF) and New Jersey Natural Gas (NJNG) to provide a powerful program to assist municipalities and school districts within the NJNG service territory in implementing Sustainable Jersey energy actions.

### Sustainable Jersey's Re-vAMPed Municipal Energy Actions

Over the past year, Sustainable Jersey has implemented changes to the Energy program actions including the implementation of new renewable energy actions and revisions to the slate of Energy Efficiency actions to award points based on energy savings. These changes up the ante in requiring ongoing tracking of energy progress. They also reward higher performance with more points. Implementing the new actions will result in municipalities having a much more sophisticated internal capacity to pursue energy and cost savings.

Learn about how these changes may affect your municipality's certification application and what you can do to maximize your energy related points.
