Don't let another year pass without achieving Sustainable Jersey certification. If your municipality is thinking about getting certified or recertified in 2017, there is **less than one month left** until applications are due. All applications must be received by **June 4 at 11:59pm**.

Remember, although the majority of your actions should be completed by this date, additional documentation can be added during the application cycle.

SolSmart Workshops

SolSmart is a national solar designation and technical assistance program funded by the U.S. Department of Energy SunShot Initiative. The SolSmart program provides national recognition for municipalities that demonstrate that they are 'open for business' for solar by having solar-friendly zoning ordinances, solar-friendly permitting and inspection processes, as well as a willingness to promote solar to community businesses and residents, as with the Sustainable Jersey Solar Challenge.

SolSmart Workshops are intensive, action-oriented sessions designed to empower communities to make significant progress toward dearing solar market barriers and achieving SolSmart Bronze, Silver, or Gold designation. Workshops are multi-day events, the duration of which are driven by the capacity, needs, and priorities of community hosts.
