FRIDAY! Roots for Rivers Reforestation Grant and Technical Assistance Program Applications Due



The Nature Conservancy of New Jersey (TNC) is partnering with Sustainable Jersey and The Watershed Institute to offer this program to municipalities, school districts, and local non-profit and conservation organizations to support their efforts to undertake floodplain reforestation initiatives on public land. Program participants will receive technical assistance to design planting projects and funding to cover materials (only trees, tubes, and stakes) associated with plantings. Projects costing between \$1,000 and \$20,000 are eligible.

As part of the partnership between Sustainable Jersey and the Center for Community Engaged Learning and Research (CELR) at The College of New Jersey, we are pleased to announce an opportunity for Sustainable Jersey municipalities to enlist students from The College of New Jersey to support your green team on a specific project that contributes to your Sustainable Jersey certification. Possible projects include:

- Establishing and/or maintaining community gardens and raingardens
- Removing invasive species from a park as part of a larger community improvement plan
- Tree and shrub planting for reforestation and erosion control (such as for the <u>Roots for Rivers</u>
- <u>Reforestation Grant & Technical Assistance Program</u>)

Projects may take place between March and April. Four to six municipalities will be selected. Municipalities may submit more than one proposal for different projects on different days. Funding Opportunities

It Pay\$ to Plug In: New Jersey's Electric Vehicle Charging Grants Program

It Pay\$ to Plug In provides grants to offset the cost of purchasing and installing electric vehicle charging stations. The program is designed to expand New Jersey's growing network of electric vehicle infrastructure, allowing residents, businesses, and government agencies to purchase and drive electric vehicles. EVs dramatically reduce vehicle emissions and improve air quality for everyone.

It Pay\$ to Plug In has expanded its eligibility criteria to include workplaces, public places, and multi-unit dwellings (apartments, condominiums, and townhouses). The program is open to businesses, governments, non-profit organizations, and educations institutions. Private residential dwellings other than multi-unit dwellings are not eligible for grants.

Upon completion of work in accordance with the eligibility criteria, DEP will reimburse each applicant for a percentage of eligible costs up to a maximum of:

- \$750 per Level 1 charging station
- \$5,000 per single-port Level 2 charging station
- \$6,000 per dual-port Level 2 charging station

Installation of electric vehicle charging stations by the municipality qualifies for points under the <u>Public Electric</u> <u>Vehicle Infrastructure</u> action. Your municipality may also consider using the siting opportunity for the charging station(s) to <u>Make Your Town Electric Vehicle Friendly</u> for additional points.
