Green Infrastructure Planning and Implementation: Find Out How to Get Your Points

This course will review the Sustainable Jersey green infrastructure actions. If your municipality is struggling with localized flooding or unhealthy waterways, you must come to this workshop. Informing Your Community about Energy Cost Saving Incentives

As a partner with Sustainable Jersey, New Jersey's Clean Energy Program™ (NJCEP) Outreach Team offers assistance to Sustainable Jersey Regional Hubs and Green Teams to provide a deeper understanding of NJCEP and its benefits to your community. NJCEP offers incentives to undertake energy audits and energy efficiency upgrades, such as the <u>Direct Install</u> program for businesses and the <u>Home Performance with ENERGY STAR®</u> and <u>Comfort Partners</u> programs for residents.

The Outreach Team is available to present NJCEP details at your Hub or Green Team meetings, providing literature and answering questions via phone or email. This information can help Hub/Green Team members become more comfortable sharing NJCEP with local residents and businesses. The NJCEP Outreach Team is available to present or participate in public outreach events organized by Hubs and Green Teams.

These resources can help your municipality earn points for the <u>Residential Energy Efficiency Outreach</u> action and the <u>Commercial Energy Efficiency Outreach</u> action. Both of these actions can help your municipality achieve the <u>Gold Star Standard in Energy!</u>

Funding Opportunities

Safe Routes to School Grants - Deadline Extended

Creating walkable and bikeable communities is a successful strategy for maintaining and restoring economic vitality and improving public health in any community. The New Jersey Department of Transportation (NJDOT) is committed to advancing projects that enhance safety, renew the aging infrastructure, improve pedestrian and bicycle infrastructure and support new and alternative transportation opportunities. These grants may be used for infrastructure (construction) projects which encourage and enable students from grades K-8 to safely walk and bike to school within a two mile radius. Municipalities, counties, schools, and school districts are eligible to apply. For more information, click here.

Application Deadline Extended: September 18, 2018

NJDOT Commitment to Communities Initiative

Applications are now being accepted for several of the New Jersey Department of Transportation's (NJDOT) Fiscal Year 2019 State Aid programs. The initiative is designed to ensure local governments succeed in delivering transportation projects that improve the quality of life for those traveling in and through New Jersey. Each of the four programs are evaluated independently, affording local governments the opportunity to receive funding from more than one grant program. **The application deadline for all programs is October 8, 2018**. Municipal Aid Program

This program funds local transportation projects, such as those that support walking and biking within the community. All municipalities are eligible to apply.

Bikeways

This one million dollar program is intended to fund bicycle projects that create new Bike Path Mileage. Special consideration will be given to bikeways that are physically separated from motorized vehicular traffic by an open space or barrier. On-road bike lanes and other bike routes and facilities are also eligible for funding. All municipalities and counties are eligible to apply.

Safe Streets to Transit

This one million dollar program encourages counties and municipalities to construct safe and accessible pedestrian linkages to transit facilities in order to promote increased usage of transit by all segments of the population.

Transit Village

This one million dollar program will award grants for traditional and non-traditional transportation projects that enhance walking, biking and/or transit ridership within a half mile of the transit facility. Eligible applicants include municipalities designated as a Transit Village.
