To promote Hackensack as a cultural destination and collaborate with other organizations to make Arts and culture more accessible to the Public. The department has supported arts and culture through many initiatives. The city purchased an old Masonic Temple and created the Hackensack Performing Arts Center, the venue of many shows each year. In addition, they built a park and an Amphitheater where the city hosts movies under the stars, outdoor yoga, and musical events in the summer. The city also hosts a series of Shakespeare In The Park and Music in the Park events during the summer.

**Program Summary:** Hackensack has a great history of utilizing its creative assets. Through the Hackensack Performing Arts Center (HACPAC), the City and the Main Street Business Alliance collaborate to bring performing and visual art to the community. From HACPAC's artistic director, Greg Liosi: "From playwrights to musicians, directors to choreographers and visual artists, we provide a platform for creativity to flourish." HACPAC hosts the Sounds of Summer Concert Series in Atlantic Street Park every Friday night in summer. On March 21-23, 2024, Hackensack High School students produced Little Shop of Horrors. The Hackensack High School Dance Team performed their "Icons" showcase on May 22nd. The art gallery on first floor of HACPAC is curated by Kim Schmitt Thomas, who focuses on both established and emerging artists. https://www.hacpac.org/elementor-art-gallery/ Soo Kim's work "Artful Solstice" was on exhibit in June. In May, the work of George Mueller was presented. In April, the work of five graffiti artists was displayed at HACPAC. Typically, their work can be viewed at Hackensack's "Grafitti Template' in Union Street Park. In March, the Hackensack Art Club displayed their pieces in the "Welcoming Spring Art Show". In February, the HACPAC hosted the Black History Month Photography Exhibition, "EXPOSURE." featuring four photographers. Streets of New York, a solo exhibition by painter Mike Rohner was exhibited in January. The Garden Club of Hackensack hosts the Arts in the Garden event at the Hackensack Community Garden in June. This event showcases local artists and artisans in the Community Garden.

Six of those buildings use the largest amount of energy – City Hall, 65 Central Avenue; Police and Health Departments, 225 State Street; Fire Department, 205 State Street; Recreation Department, 116 Holt Street; Dept. of Public Works, 120 E. Broadway; Performing Arts Center, 102 State Street. In 2024, the City is starting to benchmark with Portfolio Manager. Data will be tracked by a Green Team volunteer and updated regularly. Hackensack will continue to monitor energy expenditure and track it through the ESPM website with regular uploads.

#### **Community Gardens**

Program Summary: 1989: 7 member Hackensack Environmental Commission (HEC) adopted. 2018 HEC reorganized. Mission: Preserve open green space, urban beautification, promote a sense of community. 2019: After Internet research, site visits, interviews with nearby Community Garden leaders, and support from local universities, Medical Center, Library, Hackensack High School, Local Girl and Scout troops, HEC subcommittee determines interest and need for a Community Garden. Findings presented to City Council. Approval granted for a 75' x 130' community garden within City owned Johnson Park with adequate parking and easy bus access. Volunteers build 18 4' x 8' raised beds (36 4' x 4 beds); 1 watering station, a kiosk message board, obtain 29 large round planters, and improve handicap access. Soil provided by DPW. Two Earth Machine™ compost bins purchased from Bergen County Utility Authority. Organic garden regulations and registration forms available through City Recreation Department. Advertising includes posted signage, City Website, Internet, emails, newsletters, newspaper, and flyers. Garden receives ANJEC Environmental Achievement award. HEC presents power point on Community Gardening at ANJEC Congress. 2020: Covid protocol enacted. 15 4' x 8' plots, 2 watering stations and 1 wash station added. Girl Scouts plant daffodils and create a Pollinator Garden in community garden that receives National Wildlife Habitat Certification. Garden Club of Hackensack organizes as 501(c)3 non-profit, becomes a Garden Club of NJ member and an affiliate of Community Garden. 2021: 11 4 'x 8' plots added. GCH receives Plant America grant to plant 3 apple trees in Community Garden and beautify Recreation entrance. Boy Scout builds a raised bed for handicapped and earns Eagle rank. Gardeners donate produce to Center for Food Action, Hackensack. 2022: 1 water station added. Girl Scouts donate garden produce to Center for Food Action. Funding: Registration fees, grant, In-kind donations. Hackensack DPW and Recreation support.

## **Tobacco Free Community**

**Program Summary:** In 2014 The City of Hackensack Passed an ordinace prohibiting smoking in all Municipal building, parks and recreations facilities. Including all structures owned, leased, reanted and/or operated by the City of Hackensand and or occupied by City employees. The City also passed an ordinace in 2015 with an update in 2019 prohibiting the sale of minors under 21, and requiring signs near cash registers in establishments. Furthermore sale of all tobacco products and electronic devises MUST be dispensed to customers by a clerk from a rick or display that is behind the counter. There are smoking cessation literature available in both City Hall and the Department of Health. #### **Environmental Commission**

10 Points

Program Summary: Hackensack Environmental Commission (HEC) was reorganized in 2018 (Ordinance 35-89) as a City advisory board to increase awareness of municipal open green space preservation, green infrastructure, environmental protection and environmental justice for Hackensack's increasingly urban environment. The link to the ordinance in the eCode can be found here: https://ecode360.com/13166852 HEC projects that were begun and continue to evolve are restoration/reconstruction of the unused Green House and establishment of a Community Garden in Johnson Park. The garden has grown from approval of an unused site to an ANJEC award winning garden with over 100 4' x 8' raised garden beds, 27 large round planters, 3 apple trees, and 5 watering stations in which community Scouts built a raised bed for the handicapped and created a pollinator/habitat friendly pollinator garden. Garden produce was donated to Community Food Bank. HEC participated in Local Planning Service (LPS) Open Space & Recreation Facilities Inventory for Hackensack's 10 year Master Plan and continues to advocate for Pocket Park expansion and park protection. HEC supports the City Shade Tree Committee to upgrade Shade Tree ordinance. Investigation of ongoing grant opportunities continue as HEC has received ANJEC Open Space Stewardship Grant to improve green environment at historic Union Street Park. HEC supported Hackensack's Garden Club National Garden Club 2020 Plant America Grant award to beautify City Recreation Center entrance, and the Shade Tree Committee 2021 TD Bank/Arbor Day Grant to address environmental justice for an underserved City neighborhood. HEC advised the City to oppose construction of gas-powered North Bergen Liberty Generating Station (Resolution No. 164-19) and to oppose the Passaic Valley Sewerage Commission's proposed gas-burning power plant and supporting the use of renewable energy to achieve its resiliency goals (Resolution No. 201-22). New initiatives include applying for Sustainable New Jersey "Green Team" certification (Ordinance 44-2022), reviewing and recommending improvements to City of Hackensack's noise ordinance, and working to improve City trash management on public and private property.

residents who wish to discard medications safely at Police Headquarters, 225 State Street, Hackensack, NJ 07601. Additionally, the department hosts planned days for medicine drop off, which helps to increase awareness of this service. These events are promoted on the Hackensack Police Department's social media accounts as well as the marquee outside of city hall.
