**Program Summary:** The Borough Of Red Bank passed resolution 17-252 in November 2017. Red Bank commits to ensure proper licensing of dogs and cats, enforce all rabies and animal statutes, identify alternatives to euthanasia of adoptable animals through foster and adoption, improve animal cruelty statutes, identify and implement best practices to prevent unwanted breeding, educate the community including school children about responsibilities of pet ownership and

other important companion animals facing our community. The Mayor established the Red Bank Animal Welfare Advisory Committee to assist with the efforts in collaboration with Red Bank's Animal Control Officer. **Program Summary:** RBEC and RB Library co-hosted a panel on Lead Poisoning on Thursday, October 11 from 7-9 p.m. at the library. The panel featured NJ State Director, Clean Water Action and Clean Water Fund, Amy Goldsmith, toxicologist, former Bureau Chief of the NJDEP, Roy Meyer, and Director of Red Bank Public Utilities, Cliff Keen. Attendees included residents, parents, borough officials, EC & Green Team members. Leading up to & post event, flyers/pamphlets were posted at library, borough bulletin board as well as displayed at Touch a Truck Event held in September. # **Emergency Communications Planning**

15 Points

**Program Summary:** Red Bank maintains an Emergency Communications Plan - see attached checklist. The Borough of Red Bank has updated its communication channels and communications plan to synchronize them both so they match and reflect the technology of the day. Social media platforms and the website were reviewed, consolidated, and revised to include current

information. A new reverse automated telephone system was adopted and nearly 3,900 contacts were uploaded to the database. Public safety and stakeholders have been involved in the decision-making process and their role in the event of an emergency or incident has now been clarified and understood. All of this will now ensure a broader reach and the sharing of knowledge will promote continuity and contingency planning. Previously, this information was siloed and few people were aware of our communications strategy. We are in negotiation with Comcast and Verizon to obtain a Public Access Channel and we are installing a new electronic sign board at a prominent intersection in an effort to reach more people in a variety of ways. **Program Summary:** The Borough of Red Bank has installed a public EV charging station next to the Borough Hall. It allows Red Bank residents and visitors to park and charge their electric vehicle at a downtown location while they are shopping or dining. The charging station started operation in December 2014. It is operated by the Red Bank Public Parking Utility. The charge to the consumers is \$2/hr, which includes the parking fee. Equipement: GE EVSN3 level 2. **Program Summary:** The Red Bank Borough has a community garden located on Marion Street. It was established in 2013 and is located on borough land on Marion Street next to Eastside Park. It is currently operated by the Borough's Department of Parks and Recreation and Red Bank's Green Team offers support and advice for the garden members. This year's growing season began on March 26, 2018 and runs until November 1, 2018. The Borough contributes resources to the community garden, such as compost, equipment, water, and use of Borough property. Since 2013, the borough's contribution for supplies and equipment averages about \$750 per calendar year.

Logistics are reviewed annually by the police, fire, and health departments....the borough provides health inspection services which are paid for by the vendors. **Program Summary:** Red Bank is a vibrant and busy borough with a downtown center for arts and entertainment. Red Bank has a virtually complete sidewalk network, bicycle lanes, and sharrows. However, many residents still believe that non-motorized modes of travel receive less priority than automobiles and these barriers keep all users from accessing safe travel. Red Bank updated its original Adopt a Complete Streets policy from its 2010 and has distributed the policy within the borough to ensure all departments adhere to the newly updated policy. In addition to adopting Red Bank has completed an NJ Transit Bike-Ped Access study in 2018 where the town will implement changes made in the study to make Red Bank safely accessible to all.

Program Summary: The Borough of Red Bank initiated a voluntary green business recognition program (GBRP) in 2017. In the first year, we signed on Double Take and Hobby Masters to our program and the NJSBR and received approval from Sustainable Jersey for action points toward our Bronze certification. To date this year, we have added two businesses to our registry and NJSBR - Siam Garden and Millington Group, LLC. Local businesses in compliance with the outlined criteria for green operations will be recognized by the municipality, listed on the borough website, and permitted to display both physical and digital signage indicating participation. We have adopted the criteria established by the New Jersey Sustainable Business Registry Program (NJSBR), which includes registration of participating businesses with the NJSBR. Participation in the program will be encouraged by the municipality in conjunction with local business organizations. The long term goal is for this program to be a part of the ecological solution. One where community members, businesses, and government all participate in an awareness of each of our impacts on the environment. We feel we are a long way from there, but the baby steps are to get the local business community invested in "going green". We feel that this registration program is a way to build relationships not only with the business community, but also those within that may be interested in going green, but didn't feel like they had an outlet before.

**Program Summary:** In 2018, Red Bank brought in a new business administrator and one of his first initiatives was to review and updates all communication strategies for the borough to benefit our residents. Red Bank uses a variety of communications methods to keep its residents about important and time sensitive news in the borough through its website, email, text alerts, and social media (Facebook and Twitter). The borough is also looking to the future in discussions with cable outlets to establish an public access channel and reviewing mobile applications. The redundancies in the borough efforts through traditional, social and new media is deliberate to reach all residents and get the important information to them. In addition to its own efforts, the borough collaborates with faith based groups, the business community and our schools to share information and keep all informed. **Program Summary:** In 2018, The Borough Website www.redbanknj.org provides every piece of information that the Borough can reasonably provide to its residents including municipal code, information about town services and a complete contact listing by department. In recent years, borough Website added the Citizen Request Tracker from Civic Plus. This tracking system provides a simple interface that automatically assigns requests to the appropriate department or employee in the Borough. #### **Recycling Depot**

Program Summary: In 2017, Red Bank has a recycling depot, located at the end of Sunset Avenue. It collects the following items: paper, electronics, cardboard, glass, cans, plastic containers, plastic bags, batteries. It is open from Monday-Saturday, 8:00AM to 3:00PM. The depot is managed by Red Bank Department of Public Works. The recycling yard is located at the foot of West Sunset Ave. The facility provides residents with a valuable service that is not available to many of our neighbors in surrounding communities. As such, drop offs by individuals need to prove Red Bank Residency. Recyclable items may be dropped off at the Borough's Recycling Center during its regular hours of operation. The center is located at the foot of West Sunset Avenue. Borough Ordinance - Mandatory Recycling 19.11.1 Borough Ordinance - Streets, Sidewalks, and Sanitation Household batteries may be brought to the Recycling Center, DPW Building, Senior Center and Borough Hall. Plastic bags may be brought to the Municipal Building (this drop is managed by outside vendor), DPW Building and Recycling Center. Recycling Pick Up Schedule is available and occurs is every other week on Wednesday for all Residents. Business and Residential: Glass, tin, aluminum, newspaper, class 1 & 2 plastics are limited to one (1) 32gallon container. Cardboard must be tied with string.
