#### Establish a Creative Team

10 Points

**Program Summary:** On 5/25/17 at the regular meeting of the Green Team a motion was made and unanimously passed to form a Creative Team for Ridgefield Park. The team is organized and aided by an Arts Committee of the Green Team and the Ridgefield Park Arts Association. The Arts Committee has at least 3 members who are also on the Creative Team but the Creative Team will have at least 5 and have more members than just from the Green Team. At this point there are 38 members of the Creative Team. Members have a one year term. In 2019 the Northern New Jersey

Community Foundation was engaged to help the Village write a public arts master plan. The Foundation's process enhanced the creative team and a list of members is attached. Together with the Arts Association, the Green Team is actively engaged in several projects to increase the presence of public art. Past and current projects include musical concerts, a master level dance class, a garden sculpture in McGowan Park, downtown art walks, a mural in Vogt Park, an outdoor arts festival (Summer Arts Fest), an art exhibit in the municipal building and a Master Plan for Public Art.

## Creative Assets Inventory

10 Points

**Program Summary:** In preparation for working with the Northern New Jersey Community Foundation to create a Public Arts Master Plan an update of the Creative Assets Inventory was done. The inventory was completed by interviews of long time village residents, research at the municipal library which included working with the library's historian, a book on village history and internet searches. The village website has a note under the Green Team asking people to send information/assets they think should be on the inventory. Stake Holders for this project are Guillermo Lopez-Acosta - Pastor & Green Team, Janet Malool - Education & Green Team, Giselle Holloway - Business Leader & Ridgefield Park Arts Association, Mark Olson - Green Team, Planning Board & Ridgefield Park Arts Association & Leslie Olson - Green Team & Community Garden. To continue gathering information a new survey has been created by the Northern New Jersey Community Foundation. The survey is online at Survey Monkey and posted through village social media with Facebook groups like Ridgefield Park Moms, You've Got a Friend in Ridgefield Park and Ridgefield Park Community Garden. Public Arts Champions (Creative Team) meetings have been conducted by Northern New Jersey Community Foundation/Arts Bergen. Creative Assets Inventory has been updated and meeting notes are attached. Ridgefield Park Arts association continues to identify creative assets and will hold the next meeting of the Public Arts Champions in January 2020.

## Utilizing Your Creative Assets

**Program Summary:** On June 15th the first Ridgefield Park Summer Arts Fest was held. The purpose of the event was to showcase local art and artists of all types and support our local restaurants. Featured performers were residents/groups such as Angeles Guerreros De Dios, Joe Kenney, Joe Lustica, Larry Umaña, Latin Evening Ensemble/RP Presbyterian Church, & Spotlight Performing Arts Academy. Summer Arts Fest was run by the Ridgefield Park Arts Association with

financial support from the Green Team via a \$2,000 grant from PSE&G. Logistics and other support was provided by the Ridgefield Park Department of Public Works and Police Department. As part of the Summer concert series run by the village, residents Angel Feliciano, Larry Umana & Joe Kenny performed. Concerts are at the McGowan Park gazebo and free to the public. A mural was painted on a temporary construction fence where a new building is being constructed on main street. The Ridgefield Park Arts Association did the project. Village Artists Jocelyn Garcia and Rafael Guadalupe were among the artists who painted sections of the mural.

### Green Team

**Program Summary:** The Green Team was formed in 2016 and represents a cross-section of friends and neighbors who have come together to promote sustainability and educate our community about the different projects underway in the Village of Ridgefield Park. We intend to find opportunities to work with residents, businesses and the village to cost effectively reduce our impact on the environment through conservation and increased use of green energy options. In 2018 the Green Team continued its work by starting a public art program, helping to create an arts district in the village and many other projects. Work began on the first sculpture in one of the Community Gardens. In 2019, the Green Team plans to continue work on creating a Master Plan for Public Art as well as continue to work on educating the public about living a greener and more sustainable lifestyle. The Green Team also plans on being very involved with the Bergen County HUB. The Green Team began efforts to recycle more than the mandated items by recycling crayons, plastic bags, EPS styrofoam as some examples. The Green team was Recertified Bronze Level in December 2018 and is moving towards Silver Certification.

**Program Summary:** On May 11 the Ridgefield Park Green Team and the Bogota Green Team

sponsored a Green Fair from 10:00am – 5:00pm at Riverside Park, 24 Industrial Avenue, Ridgefield Park, NJ in conjunction with the Ridgefield Park Environmental Commission's Earth Day. Attendees were encouraged to carpool, walk, jog or bike to the event. A detailed schedule of the day's events are uploaded. Over 70 families attended and some participated in composting demonstrations. Also present were Department of Public Works Reduce, Reuse, Recycle information kiosk, Bergen County Mosquito Control with an exhibit, Rutgers Bergen County Cooperative Extension provided gardening information and advice. Ridgefield Park Grammer Schools were represented with their recycling poster projects. Education on EPS styrofoam, plastic bag and crayon recycling as well as reusable bags was added. Reusable straws were given away. Free milkweed seeds were given out. Participants that signed a pledge to use a reusable bag were given a free bag.

### Lead Education & Outreach Programs

**Program Summary:** The Ridgefield Park Health Department handles lead education outreach for the Village. Education focuses around hazards of lead paint, lead paint exposure for children/pregnant women as well as safe lead paint removal. The Health Dept. page of the website lists info on the Bergen County Childhood Lead Program offering free screenings to all families who are interested. Children are exposed to lead from different sources such as paint, cosmetics, certain foods, water, dust, soil, and time spent in a home built before 1978. (Info on website - uploaded). ### Community Gardens

10 Points

**Program Summary:** Ridgefield Park Community Garden was officially opened in April 2017. We are now starting season 3. There are 2 locations. One is at McGowan Park which is on Bergen Turnpike and the other location is in Fellowship Park on Bergen Ave and Hobart Street. Both locations are on village owned property. The estimated cost of this garden, including both locations is \$8,000 and approximately 500 hours is spent on maintenance and improvement. The day to day running of both locations is coordinated by the community garden oversight committee. This committee reports to the Green Team. This committee is currently made up of 2 green team members and one gardener. The gardeners are expected to maintain their plot and the overall care of the garden. This is primarily accomplished through group work sessions. The vegetables grown in the public plots (perimeter of each garden) are shared with village residents. Both locations have sheds and access to a running water. The gardens also creates an opportunity for community members of diverse backgrounds to meet, work and collaborate with others who have similar interests. The community garden concept is supported by our Mayor and Commissioners, and our DPW. Available plots are advertised in our village newsletter, municipal announcement board, banners at both locations, on Facebook pages and on the village website. Applications are available on our website as well as in the municipal building and library. A closed group face book page is maintained for our gardeners to share pictures, garden updates, growing tips, recipes and general announcements. Meetings reminders are posted there as well as emailed to our gardeners. Meeting dates attached.

## Environmental Commission Site Plan Review

10 Points

**Program Summary:** The Ridgefield Park Environmental Commission has taken a more active role in reviewing applications before the Planning/Zoning Board and voicing opposition to plans that would be a quality of life issue and negatively impact the environment. Since 2018, the EC has received approximately 15 cases/applications to review. (list uploaded) Re: 53 Bergen Tpke - Development of Multi-Unit Dwellings. Attached is a letter from the EC to the Board of Commissioners where the EC highly recommended that the Commissioners advise the Zoning Board to deny this application based on the variances required and to aggressively pursue the purchase of this property to address upcoming CSO State required improvements in the near future. This advice was taken by the BOC. The past year the EC has begun adopting resolutions supporting their position on different applications/issues. (Uploaded). The EC has also gone to public meetings to voice their opinion on different cases. As far as the resolution adopted and speaking at the public meeting in opposition to Area II of Overpeck Park, it was successful and the proposed Dino Park did not get approved after many public comments. There are two current applications that the EC will be sending in a letter as well as appearing at a public meeting to voice opposition to a proposed application for development. The EC also reviews various permits from the DEP such as waterfront development, fresh water wetlands applications and voices its opinion on these as well by sending letters to various levels of government as well as attending meetings to speak in support of the EC's opinion on development and projects that would negatively impact the environment.

## Community Forestry Management Plan & NJUCF Accreditation

20 Points

**Program Summary:** The Ridgefield Park Community Forestry Status Report confirms compliance with the four requirements of the New Jersey Shade Tree and Community Forestry Assistance Act. The Village of Ridgefield Park has set its tree cover goal at 27% to be achieved over the next decade. Although the current Community Forestry Management Plan indicates that opportunities for further expansion of the tree canopy cover are limited in most areas of the Village due to high density development, the Shade Tree Commission will concentrate on municipal tree replacement, and public education, awareness and outreach programs to encourage Village residents and businesses to plant and maintain trees on their properties, where opportunities for additional canopy cover are greatest.

## Tree Hazard Inventory

10 Points

**Program Summary:** Ridgefield Park has a current tree hazard inventory for every street tree in the village. Trees are rated according to the severity of the damage or threat to a given tree. An outside consultant was used to custom-design and performed the survey. The DPW is provided with a list of high priority trees that require pruning or removal. In an emergency when there is a potentially hazardous situation the tree is removed immediately. In a non-critical situation the tree is scheduled for action. The property owner is notified by the Shade Tree Commission and informed of action that will be taken. 2018 Shade Tree Commission Work Plan details the trees removed, planted and pruned. In 2019, work is underway to identify and evaluate trees in parks and other public properties (school grounds) for action.

## Tree Maintenance Programs

10 Points

**Program Summary:** Ridgefield Park has used a tree maintenance program since the inception of the Shade Tree Commission in 1979. Tree maintenance is included as part of the Shade Tree Commission's annual budget. The Shade Tree Commission uses a baseline inventory, ongoing inventory updates and additional information to keep current what is known about the public tree population. A combination of resources from the DPW and two outside arborists are used to complete the maintenance tasks which may require highly specialized equipment or skills. Any street plantings under power lines are now smaller trees to avoid conflicts with electric wires.

## Tree Planting \*New 2026\*

**Program Summary:** The Shade Tree Commission of the Village of Ridgefield Park develops and implements an annual tree planting plan. Since 1979 we have had an active tree planting and replacement program, always looking for opportunities for additional canopy cover. The Commission has committed to achieving a 27% tree cover goal over the next decade. The planting program is accomplished using a combination of volunteers and Department of Public Works municipal employees. .

**Program Summary:** Paper with a minimum 30% post-consumer content is fully adopted in the Village of Ridgefield Park departments: Clerk's office, Building Department, Municipal Court, Welfare Department and Police Department. Two invoices scanned as documentation confirming that recycled paper is in use as stated above with 30% post-consumer content. The EOY 2018 scanned invoice in preparation for the first half of 2019 and a second in July, 2019, a mid-year order. The Clerk's Office coordinates supply orders. All requests for paper are funneled through that office to insure that the departments are using paper with 30% post-consumer content.

### Prescription Drug Safety & Disposal

**Program Summary:** The Village of Ridgefield Park conducts two annual drug take-back events. The next drug take-back event will be scheduled in October, 2019 and the drop off location is the Police Department Headquarters at 234 Main Street physically inside the department's offices. Flyer is distributed and displayed at Lombardi towers, Marlboro house, senior building, 7-11, IGA, CVS, post office, as well as the eight doctors offices within the village. Information is also placed in the village website calendar, the pba Facebook page, and a NIXLE message is distributed prior to the event. May, 2019 event secured 48 pounds of drugs delivered to the DEA.

### Community Paper Shredding Day

**5 Points**

**Program Summary:** The Village of Ridgefield Park conducts two community paper shredding events annually, in April and October using an outside company. It is held on a Saturday between 9am - 1pm at the DPW Garage-24 Industrial Avenue, Ridgefield Park, NJ. where DPW employees assist residents to insure that only acceptable material is submitted for shredding. The event is publicized in the Village Newsletter, Village website, on 2 message boards one on Main Street and the 2nd on Industrial Avenue, plus shredding events are listed on the collection schedule delivered to homes each year. During 2018 the April and October event had over 70 people participating with 7 tons recycled. The April, 2019 even had 40 people bringing shredding material and 3.73 tons were recycled.

## **Non-Mandated Materials Recycling**

**35 Points**

**Program Summary:** The Green Team has partnered with the TREX corporation program to recycle plastic bags and plastic film. Collection sites are: high school, Lincoln School, IGA grocery store, This N That Hardware, public library, the First Presbyterian church and the recycling center at the Department of Public Works. Volunteers collect bags and drop them off at Target or Whole Foods. The Green Team has received two benches already from this recycling meaning at least 1,000 lbs have been collected and just earned it's third bench for collecting another 500 lbs of plastic bags. As of October 2019, 1,792 lbs. was recycled (emails attached). An expanded polystyrene (EPS) collection event in conjunction with Bogota was held on October 20th 2018. On April 22nd 2019 a permanent EPS recycling program was put in place at the Village Recycling Center, which is open to residents six days a week. To date 650 pounds have been collected. The Village Recycling Center currently recycles cooking oil in a 300 gallon tank that gets emptied by Mapoc (receipt for .536 tons attached & 190 gallons motor oil). A recycling flyer is sent to each household annually as well as published on the website and a large version is posted at the recycling depot. See uploaded recycling flyer and receipts for both cooking oil and motor oil. At the Earth Day/Green Fair celebration a collection container for cooking oil was one of the handouts for visitors. The Village Recycling Center recycles textiles. See uploaded recycling flyer. The Fire Dept. also has collection boxes around town to collect textiles to be recycled. There are signs advertising the textile collection on the collection boxes and at the recycling depot. The Green Team partnered with the crayoninitiative.org to recycle crayons. Collection boxes are at all public schools, library and Municipal Building. See uploaded flyer. A volunteer collects the boxes when full and sends them to The Crayon Initiative for recycling and donation to children's hospitals. This is a new activity but 39 lbs. were recycled so far.(documentation attached). All flyers are on the Village website [www.ridgefieldpark.org](http://www.ridgefieldpark.org) as well as electronically distributed in the schools. Info is also in the Village newsletters. Shrink wrap recycling was done with Hackensack Yacht Club which several members of the of the village are members of. During the fall and spring boat preparation process 327lbs of shrink wrap were collected and delivered to Target/the Trex program. Non-mandated recycling 35 pts: bulky rigid plastics (10), cooking oil (5), textiles (5), shrink wrap (5). Other 10 points {plastic bags, crayons, EPS, cigarette butts, motor oil - these items are worth an additional 10 points for other non-mandated items}. Twice a year the collection calendar gets delivered to homes. It is also on the website. Paper shredding is advertised on website and online, as well as town message board and DPW message board. Materials are handed out at the Green Fair. The DPW usually has 1 or 2 school groups each year that come down for a tour and are given info to share with their families. When new residents move into town and request info, the DPW makes up a packet and drops it at their home. It includes the recycling info, calendar, a recycling sticker for their can, info from BCUA on hazardous waste and put it in a reusable shopping tote. There is also a large sign at the recycling depot explaining all the various items that can be recycled. This is also printed in the village newsletter and on the website as well.

## Recycling Depot

10 Points

**Program Summary:** The Recycling Center in the Village of Ridgefield Park is open six days a week (M-S 9am - 12pm) and manned by a Village employee who guides residents through the deposit process. A recycling board that details what Village residents can drop off at the center has been posted which includes the information shown below: computers, small appliances, TVs, DVD players, etc. metal, wood general trash yard waste corrugated cardboard propane tanks used automobile oil commingled recycle (glass, plastic, aluminum) newspaper, magazines and junk mail Residents contact the DPW to arrange specific pickups for washers, dryers, refrigerators, hot water heaters and large objects made of metal.

## Materials Reuse Program

10 Points

**Program Summary:** The Village continues to operate their Materials Reuse Program at the DPW Recycling Center and as part of our overall recycling program. Several items were taken from the materials reuse area within the recycling depot, cleaned up and given away at the Earth Day & Green Fair. (photo uploaded from 2019 event) Uploaded is the Materials Reuse Sign which designates the area for residents to drop off their items. Since the Materials Reuse Program has been active for a number of years, the volume remains constant. The DPW caretaker of the area maintains that well over 200 people go to the materials reuse to either drop off or pick up an item which saves minimally 2 tons of material from landfills. He also tries to match up what is brought in with people in need of items. People who stop by the recycling center are shown available items and instructed they can also drop off items they no longer need. Attached is the notice that

has been in the Village newsletter, website and distributed in the schools. The flyer is also available at public events such as Earth Day, annual Street Fair, etc.
