Animals in the Community Education

10 Points

Program Summary: The Island Heights Library provided several educational activities for 2018 including topics such as Responsible Ownership Education, Positive interactions with Dogs, Wildlife Interaction, Pollinators and more. 1. Children Make Terrible Pets Education activity about the responsibilities of having a Pet and responsible ownership, shows children how having a pet is not all about fun and treats. The story also teaches children that no every animal can be a pet, some belong to their own habitat. Activity was on Wednesday, August 15, 2018, 10:30 AM and took place at the Island Heights Library. This puppet show was based on Peter Brown's Children Make Terrible Pets. Type of Event: Program. Audience: Kids. Age Range: Ages 2 and older. 2. Read to a Dog Program The main objective of this program is to provide a relaxed and "dog-friendly" atmosphere, which allows students to practice the skill of reading but also helps children to learn about dogs and be more comfortable around them. Most children just seem to naturally love animals, and especially dogs. Unfortunately, not all children are comfortable around dogs. Some children that have not had an opportunity to be with dogs have a fear of them. As a child interacts with a therapy dog, they develop a better understanding of a dog (www.tdi-dog.org). Island Heights had 2 Read to a Dog events on 2018, first on May 25th and the second on July

27th, next event will be on August 31st. Type of Event: Program. Audience: Kids. Age Range: 5 and up. 3. Howling Woods Farm This presentation was about history and conservation of wolves and wolf hybrids from Howling Woods Farms. This will be about 45 minutes, and guests will have the chance to see wolf-dogs up close. 4. Live Animal Talk for Teens! A naturalist from Cattus Island County Park dispel the myths and fears of reptiles. Assistants got to see live snakes and turtles and discussed the characteristics and conservation of these native species. Activity was on July 23rd at 6:30 pm and took place at the Island Heights Library. Audience: Ages 12 – 18. 5. Unique Creatures - Island Heights Library Children learned about animals from all around the world, about each creature's habits, environment, and diet and real life strange powers. Presented by Larry Apap of Unique Creatures. Activity was on Aug 2, 2018 at 12:00 PM and took place at the Island Heights Library. Age Range: 5 and up 6. The Amazing Honey Bee Join David Elkner from the South Jersey Beekeepers Association spoke about the benefits and importance of beekeeping. Hive components, parts, equipment, the frames of honey, plus why we need to help protect the amazing honeybee. Event was on Monday, Jun 18, 6:30 – 7:30pm at the Island Heights Library. Also there is information available all year round at the Library

***** Island Heights Borough has signs showing the importance of picking up pet waste and sanctions for violating the ordinance ((Island Heights General Ordinances CHAPTER VIII ANIMAL CONTROL8-1.12 Curbing of Dogs and Cats and Pet Waste.) Information about the importance of picking up animal waste was posted on the Sustainable Island Heights Facebook page to reach our followers on social media, responsible ownership and proper waste disposal it's fundamental to create a healthy environment and avoid water pollution. We also shared pet safety information about weather temperature for dogs to be outdoors, also the risk during the holidays for pets to eat poisoning or hazardous products that are common during holidays like chocolate, decorations or other. We held a free Rabies Clinic 1/20/18. ***** We have educational signage about the detrimental effect of feeding waterfowl. We created a wildlife tree and provided birdhouses and birdbaths in the IH Children's Garden for the birds. Island Heights is pursuing the certification as a Community Wildlife Habitat, as part of this program we distribute educational material about the importance of Native plants to attract pollinators and how attracting Birds helps to control the bug population without then need of chemicals. We try to focus on the importance of bugs and birds to the environment.

Program Summary: For a Creative Team we have the Island Heights Cultural and Heritage Association, it was founded in 1978 by a group of residents prompted by the spirit of civic pride during the Island Heights Centennial Celebrations. It is a non-profit (501c3) corporation dedicated to promoting the rich, historic, artistic and architectural heritage of our river/bayfront community of Island Heights. The Association offers assistance in the interpretation and care of historic properties, and actively collect local historic artifacts and ephemera to preserve for future generations. Also they offer Garden Tours, Historical Tours and participate and host Environmental and Emergency Management activities. This Association is a very active group in our community, they meet monthly at the Island Heights United Methodist Church and have a guest speaker at their meetings. In April 2019 the guest speakers were from the NJ Plant Society talking about native plants and the Environmental Committee introducing the Wildlife Habitat Certification. In May 2019 Local Artist and Videographer Peter Slack was the guest speaker. Currently the IHCHA is working on their Secret Garden and Scenic Porches Tour which is scheduled for June 22nd 2019 and it is a wonderful educational tour about gardens and Victorian architecture.

Program Summary: The Island Heights Green Team and the Creative team collected the information necessary online, by interviewing groups and organizations, and through the available historical material on the Municipal Building, resolutions and ordinances were used as well the town's Master Plan and other available plans for Ocean County and the Watershed. The Creative Team IHCHA provided pictures and some of the narrative for the creative assets inventory. The inclusion of assets was discussed on the Environmental Committee meetings to assure the input of every member and to not miss any possible asset on the inventory, notes were also added after every event during 2017 and 2018. Every organization was interviewed to know more about their events and meetings. Founders Day was key to getting to know every group in Island Heights. The three-day event opened the doors of interaction and cooperation between organizations and committees. This information was collected, analyzed, and synthesized in order to describe the cultural resources of Island Heights. A Recreational Areas Map was created on Google Maps with the intention of creating a graphic vision of our open spaces.

We not only gave information about certifying their gardens, but also about the importance of native gardens with a list of native species for our geographical area as well as composting. We currently have 2.25% of the households enrolled since we started the program this year.

Hold a Green Fair

10 Points

Program Summary: The Island Heights Environmental Committee and Green Team hosted the Island Heights Earth Day Celebration on April 27th, 2019. The event was held at Wanamaker Field, a waterfront open space that features a Bioswale, Community Garden, Monarch Garden, and Children's Garden. The event started with a Ribbon Cutting Ceremony for the Children's Garden, which is an ANJEC grant funded project as well as a local Girl Scout's Silver Project, and local Cub Scouts built a Pop Up Library and local Girl Scouts added a wheel barrel garden bed there too. The ceremony included a small tour of the garden improvements like the removal of invasive species and the addition of all native species, a clam shell path, the installation of the TREX Bench earned with the plastic bag recycling challenge as part of a Girl Scout Gold Award project, the Pop Up Library, some upcycled decor rescued and donated by the Environmental Committee, and the Sign certifying the garden as a Wildlife Habitat (NWF). The Local Ballet School, Shore Ballet, performed a Butterfly dance to start off the celebration and it continued with Zero Waste Refreshments and an invite to everyone to visit the line up of local Eco Friendly Vendors and Educational Non Profits. Our vendors were the Little Plant Company, Wild Birds Unlimited, Beth Francis Handmade, Eco Chic Chick, Aromasana, Surf Dawgs, Shore Ballet, Seaglass Treasures, Eclectic Homestead, Modere, Bubbys Beanery, Eco Pool Drain, and EZ Energy. For Non Profit Organizations, we had Save Barnegat Bay, Endangered Wings, Pittie Project, Friends of the Island Beach State Park, and Island Heights Friends of the Library. Unfortunately a local beekeeper and some community groups had to cancel last

minute due to the strong winds. Vendors were selected according to their Sustainability factor and we encouraged local small businesses to participate. We stated our goal of a Zero Waste event and were 100% successful. The local restaurants were notified of the Earth Day Celebration and invited to join us by offering a skip-the-straw campaign. To publicize their efforts on sustainability, we offered assistance in designing flyers or posts if they wanted and we encouraged people to visit their establishments instead of having food trucks on site. During this event we hosted special recycling drives such as Styrofoam, Plastic Toys, #5 plastics, bottle caps, alkaline batteries, toothbrushes and toothpaste tubes, contacts and blisters packs, and we gave advice on recycling and eased doubts on the matter. We collected 18.8 lbs of plastic caps and #5 plastic, over 60 toys (donated to OCEAN Inc. Head Start through Second Chance Toys), approx 3 large garbage cans of Styrofoam (Dropped off at Foam Pack) and a smaller amount of the other waste streams (Will be recycled with Terracycle). A Townwide Clean Up was also part of the event activities, we gather 15 volunteers and supplies were donated by NJ Clean Communities. We gave away Native Seedlings (Bayberry, Beach Plum and Silky Dogwood) and a Free Coffee at Bubbys Beanery for a bag of litter. Volunteers could also participate in a raffle for a Zero Waste Basket full of eco-goodies donated by The Natural Health Food Store to help on their journey to a more sustainable life. The excess seedlings will be planted all over Island Heights to add more beautiful Native Plants to our landscape. We appreciate Dental Lace, Eco Fella, and Hello Products for providing us with free samples of their sustainable products. As well Bubbys Beanery for supporting and donating free coffees for our volunteers, Natural Healthfood Store for the Zero Waste Basket Raffle, and Peter Slack Photography for the wonderful pictures of the event. Vulnerable Populations Identification for Emergencies

10 Points

Program Summary: Island Heights identifies vulnerable populations to ensure they receive the help and information they need during emergencies. Each year a flier is sent out by the OEM to all residents. It asks for anyone who may need assistance during an emergency to identify themselves. This includes hearing impaired, mobility-impaired and vision-impaired citizens, people with medical conditions that require special equipment and un-interrupted power, and any other medical condition that would indicate that assistance would be needed in the event of a long term power outage or if an evacuation is necessary. The OEM works with the Police Dept and First Aid Squad to ensure we are aware of those individuals and that we have the capabilities to provide any assistance that might be needed for these and all citizens. These forms can be filled out and dropped off at Police Headquarters. Also the Island Heights Website includes a link called "Please Help Us Help You! Food

Community Gardens

20 Points

Program Summary: Island Heights has a Community Vegetable Garden that started in 2016, as an IH Environmental Committee and Green Team project. It was built by Pinelands Antique Engine Association club with the support and approval of the IH Mayor and Town Council. The first year had only 48 beds but by 2017 an expansion of 20 beds was necessary due to the high demand and a waiting list for beds. The town rents the beds yearly in two sizes: 5x12' and 13x12'. This garden is located at Wanamaker Field on Municipal Property next to the Police Department. This is the Fourth year for the community vegetable garden. The garden has 57 beds. In 2019, two community herb plots were added and a community watch continues to keep the garden safe. There is a compost pile and 2 medium composters were added in 2018. The beds cost \$25 for a 5' x 12' plot and double-sized beds are available for \$50. The garden permit is purchased at Boro Hall. Educational materials are distributed to the gardeners, including topics on native gardens, organic gardens, composting, and more! Gardeners are provided continuing education opportunities throughout the year, in 2019 we conducted a composting class at the garden (June 2nd, 2019) and we always encourage the gardeners to sign up for the Ocean County Master Composter class. There is currently a waiting list of approximately 15 people for a bed of any kind for 2020. The community garden donates vegetables to the Island Heights United Methodist Church Food Pantry which opens on Tuesdays. In the 2019 summer the biggest contribution has been tomatoes, providing fresh produce to those in need as well.

Program Summary: The Island Heights Farmers Markets started in 2017, reopened in 2018 and is continuing in 2019. This is organized by the Island Heights Town Council, the vendors are required to pay a fee of \$35 a week per stand. In 2019 our vendors include: Farmer's AI, Eco Chic Chick, Aromasana, Bakery 502, Caldinos, Simply Sofrito, Beckage Farms and Di Alfredo. Our vendors are very open to Sustainability and offer low waste and plastic free options. The Island Heights Farmers' Market offers a variety of locally grown fruits and vegetables, jersey corn, tomatoes, blackberries, beets, zucchini, kale, flowering plants, basil, spices and flavored oils, seafood cakes, pasta, pickles, baked goods, handmade jewelry, and more (WIC and Senior FMNP vouchers accepted by some farmers). It is located at 1 Wanamaker Complex on the Corner of East End and Westray Ave., Island Heights, NJ 08732. Market dates and hours of operation are June 3th - October, 2019 for regular farmers market, Tuesdays, 2:00pm -7:00pm (Moved from Mondays) The Municipal Government approved the hours and days of operation at the Mayor and Council meeting on May 14th. Schedule will be on their website and the news bulletin board located at Town Hall The Green Team also promotes the farmers market on social media to attract more customers. The IH Market has a FB page to share information about the vendors and days of operation. For 2019 the vendor enrollment form is online via google docs and the vendor priority will be to Island Heights Residents. The participating farmers must produce their own products and be open to an on-site inspection to ensure that all products are local. According to the Revised General Ordinances of the Borough of Island Heights Smoking of cigarettes or other tobacco products is prohibited from the following outdoor locations: 1. Summit Avenue Bathing Beach 2. Betty Scammell Memorial Park (which included the ball field, the playground, the skating rink, the basketball court, the tennis courts and the soccer field); and 3. The Wes Wilber Park (located next to the police station). In 2007 this ordinance was presented during the Mayor and Council Meetings on April 24th and May 10th 2007, and the

public was notified via Newsletter which was printed and mailed to all the residents and which was also available at town hall. Program Summary: ***Update 2018*** This year, 2018, we certified the Bioswale as a Wildlife Habitat (NWF certification) during the month of April, and put up a sign for people to know about the project. Several neighbors talked to us about how wonderful this project is and how the Bioswale is been a point of reference for the residents to include the same kind of labeled vegetation and design in their gardens. All the plants used in the project are native and were planned to display a 4 season landscape. There is also an informative sign at the Bioswale explaining it. Also for Earth Day 2018 we conducted a Bioswale Clean up and Weeding. The Environmental Committee is also consistently cleaning up and weeding the Bioswale to keep it in perfect condition. ***Project Description*** Island Heights created a Bioswale with funding from a \$20,000, 2012, Sustainable Jersey Small Grant. This has been a successful project. The grant was completed in 2015, and we continue to maintain and improve the Bioswale with plantings, cleanups, and tours. Our Bioswales were created in existing parking lot medians at the Island Heights municipal complex in order to relieve a flooding problem and to treat stormwater runoff. It continues to serve as an example for our residents and visitors to IH. The Bioswale works as planned. It absorbs the water from the parking lot and allows cleaner and cooler water to flow into the Barnegat Bay. Efficient Landscape Design

10 Points

Program Summary: Island Heights implemented green landscaping and grounds maintenance to control and manage rainwater, help reduce erosion, and improve the natural conditions of our public spaces to attract wildlife and improve water quality and efficiency. Some of our gardens include: Children's Garden (2019) Project funded by ANJEC. Removal of Invasive Species, Added Native Species, added a Bug Hotel, Birdhouses, Bird bath, and clam shell path. Island Heights Grade School Rain Garden (2018) Project funded by Sustainable Jersey. It was intended to help reduce erosion, attract wildlife to the school property, serve as an educational opportunity, and reduction of the lawn. The garden consists of all native plants, a clam shell path, and a rain barrel to help water conservation. An appropriate site was chosen with the help of the Island Heights Environmental Committee Chair and Green Team Member, Mary Judge, as well as Dr. Steven Yergeau of the Ocean County Rutgers Cooperative Extension. A landscaper who specialized in native plants (Native Designs, LLC) was hired for the installation. A painted rain barrel from the NJDEP Rain Barrel Challenge was installed at the head of the garden to provide water for the plantings. The garden unveiling event was on Earth Day 2018. Library Jersey Friendly Garden (2017) The Island Heights Friends of the Library created an all native garden and removed all invasive species, they also certified it as a Wildlife Habitat. This project was funded by the Barnegat Bay Partnership. IH Bioswale (2016) Project funded by a Sustainable Jersey Small Grant. The Bioswale was installed at the Wanamaker Complex Parking Lot. It helps capture and filter nonpoint source pollution runoff before it enters Barnegat Bay and also alleviates the flooding that previously occurred in this parking lot. Monarch Garden (2016) Funded by an ANJEC grant. This Garden Was created in the middle of the Community

Garden with the intention of attracting pollinators required for optimal vegetable production. As of 2019, the garden is doing wonderfully, the milkweed and other plants are even spreading into the community garden which only indicates the health of this wildlife habitat. A mowing policy has reduced the mowing area of municipal lands by mulching, planting wildflowers, or allowing for meadow growth instead of lawn. These areas contribute to a healthier ecosystem, and reduced mowing also reduces the greenhouse gas emissions from lawnmowers. Efforts have also been made to restore native vegetation in the landscape, encouraging biodiversity and resulting in lower maintenance needs. Stormwater is also managed by 150 detention basins, many on private properties that filter pollutants and recharge groundwater

Minimize Water Consumption

Program Summary: In order to reduce water consumption, invasive species have been removed and native plants have been added to open spaces in Island Heights, and three Rain Barrels were installed on Borough property. Premises are only watered at early hours to reduce evaporation and only if absolutely necessary; for example, when new plants are added. Deep watering is done on new gardens to ensure the growth of the roots which, when established, will help to absorb more water and eliminate or reduce the need for watering. Lawn Reduction, native gardens, and native plants in general, allow Island Height to stay green and vegetated all year without the need of intensive landscape care.

Recycled Materials and Composting

10 Points

Program Summary: The Island Heights Public Works and Recycling Center accepts leaves and brush, which get composted by Ocean County and come back to our recycling center as mulch. This mulch is used by Public Works and also made available to residents for free throughout the year thanks to this Ocean County composting program that Island Heights participates in. During the spring the community garden utilized a load of the mulch to reduce weeds before planting season. The community garden has composting bins and a brush bin for the gardeners to use. These bins are also made available to the vendors during Farmers Market Season to dispose of their appropriate waste such as the avocado pits and skins from the guacamole vendor, veggies that got damaged en route, etc... In 2018 the Environmental Committee and Public Works organized a Pumpkin, Straw Bale, and Corn Stalk drive after the fall festivities to reduce the volume of organic waste to the landfill. The Children's Garden inaugurated in 2019, included the installation of a TREX bench obtained by recycling 500 lbs of plastic bags and film, also the decoration added to this space was salvage and up-cycled, two fireflies made of old silverware, a planter made of a wheelbarrow, a children's library made of construction leftovers, two seats made of old tree stumps, and wind chimes made of bottle caps. Unused machinery from public works is usually auctioned and unusable electronic material gets recycled by our Electronic Recycling Program.

Program Summary: Guidelines for recycling in Island Heights are regulated and mandated by the Recycling Regulations of the Borough of Island Heights ((Ord. No. 88-04 §1) See attached). This documentation includes the rules, methods of enforcement, and penalties for violations. Please see the attachments with some of the outreach and informational materials, both print and digital, with which IH residents are provided to ensure their understanding and compliance with town recycling policies and practices as well as educational materials encouraging additional ways to recycle, compost, rethink, reuse, and refuse, helping our residents make wiser choices to reduce the amount of trash sent to landfills. Recycling information is available online, at the Municipal Building, at the IH Post Office, and at The EC Farmers Market Stand. The Green Team and Environmental Committee also give out information about recycling and waste reduction during events such as Earth Day, Founder's Day, Farmer's Markets, Steam Fair, and more. (see attachments) Facebook is also a great tool and our page, Sustainable Island Heights ([facebook.com/SustainableIH](https://www.facebook.com/SustainableIH)), is the page we promote to residents to access recommendations on recycling and reducing waste (Zero waste ideas, use this not that, etc.). Also, several special recycling programs are up and running and changing the perception people have of waste and encouraging them to find other options instead of tossing stuff in the garbage. This app helps people find the best ways to dispose of their waste and includes the rules for single-stream recycling for Ocean County/Island Heights and also allows the opportunity to create reminders. Island Heights promoted the app on the EC Community Board, at the Farmer's Market, our Sustainable Island Heights Page, and now is live on the town's website as well, see here: <http://islandheightsboro.com//recyclecoach/> We have uploaded a report from the Ocean County Board of Health including 6 recycling inspections in Island Heights, according to our ordinance, the Recycling Coordinator, the Code enforcer, and the Board of Health officials are the ones in charge of recycling inspections and enforcement. We also uploaded the letter indicating no inspections were conducted by the Borough during 2020. The solid waste collectors will not collect single-stream recyclables with visible non-recyclable materials in the cans as a way to help ensure proper compliance from residents and to keep the town loads free from contamination with non-recyclables.

The event was advertised on the community boards (which we find more effective for our population) and a Facebook event was created and advertised to residents of Island Heights. (See Attached) This year we transferred the event to Wanamaker Field, because the logistics and the space were more appropriate for the traffic at the event. At 8:30 am there was already a line waiting for the event to start, we had over a hundred vehicles attend this shred. We collected 2.48 tons of paper from the event. Autos shred provides the shredding trucks and drivers free of charge as long as we are able to net them an agreed upon amount of paper. Program Summary: Current Programs 1. Plastics 1.1 Plastic Bags: Trex challenge completed at the end of 2018 1.2 Plastic cups: Collected and recycled with Terracycle free brigade program and also Subaru provided 3 bins, 1 was sent at the beginning of the year, the 2nd one is still in progress. The Environmental Committee also collected plastic cups from the school events in 2019, the Halloween parade of 2019, and the Summerbrew from 2019, these cups were recycled via TerraCycle. 1.3 Oral Care waste program: Items collected during the Farmers Market or pick up from one of the Environmental committee volunteers, materials are sent to Terracycle. This program accepts toothbrushes, toothpaste tubes, floss packaging, mouthwash caps, and any plastic packaging from dental care. 1.4 Dog food packaging: Wellness food and treats packaging program by Terracycle 1.5 K-cups: Subaru provided 3 boxes, we have the same collection logistics as the Candy Wrappers, but the 1st box is still in progress, no boxes sent yet. 2. Candy and Snack Wrappers: Our Environmental Committee and Green team contacted Subaru to participate in their "Loving the Earth means preserving it" program partnership with Subaru. They provided 4 Bins from 2019 to 2020. Our collection centers are the Pre-k, Environmental Committee Stand at the Farmers Market, Save Barnegat Bay Eco-Center and, arranged drop off via text, Facebook, or Instagram. We already shipped 2 full boxes. 3. Second Chance Toys Program: The Environmental Committee Organized 1 collection in 2018 and 2 in 2019. Our second year was so successful that we collected over 400 toys on our Christmas Drive.

Backyard Composting Program

5 Points

Program Summary: June 2nd 2019 we offered a class called Composting 101, where we spoke about the basic steps to start composting, class was at the Island Heights Community Garden and it was free and open to the public. We had 13 residents during the class and after the class we visited the 2 composters on the community garden.

During the Farmers Market season we distributed Materials about composting at home and Kids Can Compost Too! Also we answered questions and helped introduce neighbors to the idea of composting at home!

Our Community garden has compost pile, a brush pile, and two small composters inside the garden, which are also used by the farmers market to dispose of any leftover compostable materials. Information about composting is distributed and shared with the Community Gardeners to ensure that all the waste from the garden is composted.

During the Farmers Market Season we also reached out to the vendors about Composting and rethinking their way of disposing leftovers.

A Master Composter Training Program for Ocean County residents was held on Saturdays, and Nov. 3 and Nov 10 2018 from 9 a.m. to 3 p.m. at the county's Recycling Education Center at the Ocean County Northern Recycling Center. Event was originally scheduled a week before but was changed due to the weather. This program was offered by Ocean County's Department of Solid Waste Management and the Ocean County Board of Chosen Freeholders. The course was taught by Sandra Blain-Snow, an Ocean County Master Composter and Island Heights Councilwoman and Green Team Member. Three Members of our Green Team joined the class to learn more about composting and to be able to train more community members. The class was advertised on our Sustainable Island Heights Page inviting the community to participate in this free course, and the Island Heights Borough had information at the Municipal Building about the program. The invitation to apply was emailed to all the Community Gardeners and everyone on our mailing list.
