Sustainable Jersey provides updates and introduces new actions in January and June of each year. Action updates are divided into two categories:

**Major Updates:** Significantly change the submission standards for an action that either make it harder or easier to obtain points after the revision. It can also occur when an action is being proposed for withdrawal from the action list or being removed as a priority action in the program.

**Minor Updates:** Changes to action spotlights, resources, or clarifications to improve performance and do not change the standards.

### **Program Changes Since 2009**

In 2010, Sustainable Jersey added an additional level of certification, creating a Bronze Level and a Silver Level. Bronze certification still only requires completion of two (2) Priority Actions, while Silver requires three (3). Additional Priority Actions have been added, while some have been removed. Additionally, any new actions have been added and options for receiving points in multiple categories have been expanded. For example, in 2009, if you had five recycling advancements, you could only receive credit for two; however, we now have more options for receiving credit under the Recycling Actions. The point system was also adjusted to keep the level of effort required to achieve certification similar to the first year of the program. Since it is now easier to score points, and there are more points available, the minimum points for the Bronze (or first level of certification) increased to 150 points from 100 points. Finally, a new level of certification was added, Sustainable Jersey Silver, which requires 3 priority actions, 350 points, and actions completed in at least 8 categories.
