#### Sustainable Jersey Grant Recipients in Action

The Sustainable Jersey Grant Program has funded 1,215 projects in municipalities and schools. Some of the projects completed include: a \$2,000 grant for a Seed Saver program in Mountain Lakes (top left); a \$10,000 grant for the installation of water bottle refill stations in Red Bank to provide access to clean water and environmental education (top middle); a \$2,000 grant for green team support and a rain barrel workshop in Egg Harbor City (top right); a \$20,000 grant for a Single-Use Plastics Reduction Campaign in Galloway (bottom left); a \$10,000 grant for a community garden in Berkeley Heights (bottom middle); and a \$10,000 grant to install an irrigation system at the community garden in Mount Olive (bottom right).




