## Why Green Purchasing?

Green Purchasing is the coordinated purchasing of goods and services to minimize impacts on human health and the natural environment.

A simple first step is to purchase products made from recycled content that are themselves recyclable.

GREEN PURCHASING moves beyond recycled materials and takes into consideration:

- The raw materials, including energy and water; used to manufacture products
- The production process itself
- The packaging and distribution method
- The distance of transport and proximity of production

## **Benefits of Green Purchasing?**

Implementing a Green Purchasing Program can:


- Protect the Environment- Green products eliminate waste, reduce hazardous toxins in landfills and use efficient manufacturing processes
- Save Money- Reducing and reusing products means less purchasing and lower costs
- Protect Human Health Green products eliminate exposure to corrosive or irritating materials containing toxic compounds that can contribute to serious health effects to humans and damage to the environment
- **Conserve Natural Resources-** Green products promote conservation of nonrenewable resources, protect water quality, conserve water, and support sustainable forestry practices
- Reduce Greenhouse Gas Emissions- Energy efficient products and production practices
  minimize greenhouse gas
- Support Sustainable and Healthy communities and social structures

## Green Purchasing Importance in NJ

"Recycling keeps millions of tons of materials out of landfills and other disposal facilities, conserves natural resources, saves energy, and reduces emissions of water and air pollutants, including greenhouse gas emissions which lead to climate change."

Developing strong markets that use recycled material feedstocks in their production processes will expand recycling markets.

By purchasing recycled products, schools and local governments can help to close the recycling loop and strengthen the state's economy.



## **Green Purchasing**

Nationally Recognized Green Certification Programs

- Sustainable Jersey relies on national certification programs that use scientific research & technical guidance to certify products and services that meet rigorous standards.
- New actions that focus on expanding the purchasing of products with both post consumer and pre-consumer recycled content will rely on the USEPA <u>Comprehensive Procurement</u> <u>Guideline</u>













## When "green" is not Green



Want to purchase "green" copy paper

- Best option to search vendor for 30% post consumer recycled content copier paper
- NOT companies "green paper" designation
- One major office supply company has their own "green" designation and copy paper labeled sustainable may NOT be 30% **PCRC**

## **Green Purchasing Actions** Municipal Program

- Green Purchasing Policy "Updated 2023" (5-10 pts)
  - New feature requires proof of implementation for recertification
- Green Cleaning Products & Motorized Cleaning Equipment "Updated 2023" (5-15 pts)
  - Must meet national certification standards and meet minimum % of purchase requirements
  - Extensive list of cleaning supplies and motorized equipment like floor cleaners & vacuums
- Recycled Copy Paper "Updated 2023" (5-15 pts)
  - Copy paper must contain 30% Post Consumer Recycled Content
- Green Maintenance Equipment and Materials (10 pts) \* will retire in 2024

## **Green Fleet Actions**

#### - Fleet Inventory (10 Points)

- Fleet analysis shows which vehicles can be replaced with EVs with cost-effective result
- Purchase Alternative Fuel Vehicles (5-15 Points)

The Maplewood Police Department loves their fully-electric Ford Mustang Mach E which they purchased from the NJ State Contract.

- Public EV Charging Infrastructure

Installation of municipally-supported

public EV charging stations

### **Green Purchasing Actions** Municipal Program- New Actions Coming in 2023

- Recycled Office Paper and Restroom Supplies (5-15 pts)
  - Hand towels, facial tissue, bathroom tissue
  - Corrugated storage boxes



- Miscellaneous Paper Office Supplies- envelopes, labels, file folders note pads
- Recycled Recreation and Transportation Products & Materials (5-15 pts)
  - Recreation –bike racks, park benches, picnic tables, playground equipment, recycled plastic lumber
  - Transportation products- channelizers, parking stops, traffic cones & barriers
  - Roadway pavement and fill materials with recycled content

### **GREEN CLEANING**

- Green Cleaning Policy & Plan (10 pts)

#### - Green Cleaning Equipment (10 pts)

- 100% certified green cleaning products in areas occupied by students and staff
- Green Cleaning Training & Education Programs (10 pts)

### **GREEN PURCHASING**

- Green Purchasing Policy (10 pts)
- Recycled Paper Purchase (10 pts)
  - At least 25% of copy paper purchased during school year must be 30% PCRC
- Sustainable Fleets (5-15 Points)
  - Electric school buses and other fleet vehicles

### NJSTART – What is it?

NJSTART is The State of New Jersey's online purchasing system for the Division of Purchase & Property (DPP)

- The Division of Purchase & Property (DPP) is within the NJ Department of the Treasury and serves as the State's central procurement agency
  - NJSTART includes all contracts that are a part of the State's Cooperative Purchasing Program
  - DPP's Cooperative Purchasing Program was established by legislation & extends specific State contracts to eligible local buying units
    - Examples of "local buying units" are: Municipalities. Counties, School Districts, Volunteer Fire Departments, Volunteer First Aid & Rescue Squads, County & State Colleges, Independent Authorities, Quasi-State Agencies. Independent Institutions of Higher Education

## **Purchasing Authority in NJ**

Public School Contract Law – N.J.S.A. 18A:18A

- Bid and Quote Thresholds
  - QPA (Qualified Purchasing Agent) Thresholds
    - Bid threshold = \$44,000/Quote threshold = \$6,600
  - Non-QPA Thresholds
    - Bid threshold = \$32,000/Quote threshold = \$4,800


## **State Contract Purchases**

#### N.J.S.A. 18A:18A-10

- Permits a board of education, without advertising for bids, by board resolution to purchase any goods or services pursuant to a contract entered into on behalf of the State by the Division of Purchase and Property
- These contracts can be found in NJSTART
  - Typically contracts are for more than 1 year

## **Green Purchasing**

- Refers to the procurement of products and services that minimize impacts on human health and the environment.
- Start with a Green Purchasing Policy
  - Guide for what to consider when making a purchase
    - Materials, the production process, packaging and location



## **Green Products**

- Cleaning/Maintenance Products
  - Eliminate ammonia based products
  - No Bleach Policy/Use H2O based products
- Container Take-back Programs
- Electronics and Equipment
- Food for School Cafeterias
  Buy from local farms
- Lawn Care
  - -Herbicide and Pesticides

- There is no charge for the 96 gal. roll-out carts (1 Solid Waste & 1 Recycling)
- One (1) 2½ CY Rolling Container for each business & condo (1 Solid Waste & 1 Recycling)
- A ten (10) year warranty is included
- Additional carts will be available to purchase at the Coop Price w/ a limit of two
- Every cart has ID code, so it can be returned to the property owner in the event of a storm or flood & all lids are affixed

#### TREES FOR SCHOOLS PROGRAM, TREE-PLANTING GRANTS FOR NJ PUBLIC SCHOOLS, COLLEGES AND UNIVERSITIES

The Trees for Schools program will provide **\$2.5 million** in grants to New Jersey public school districts, county colleges and state colleges and universities to fund the planting of trees on campuses across New Jersey. Competitive grants of **\$10,000 to \$500,000** will fund costs associated with planning, site preparation, trees, planting, watering, monitoring and related expenses over a three-year period. Applications are due on **July 13, 2023**, for spring 2024 plantings. An informational webinar will be held on **May 18, 2023 from 3:00pm - 4:30pm**.
