### What is the process of a PIE Tech Assessment?

- Initial survey of local communication and public engagement ... your community and government's vision, needs, challenges, opportunities, and capacities,
- Virtual visioning workshop with key local stakeholders,
- Interactive virtual triage and prioritization exercises with key stakeholders,
- Draft Action Plan,
- Review/discussion period,
- Final Action Plan,
- Optional: Presentation for governing body and/or key stakeholders, and
- 6 and 12 month follow up surveys.



#### What are some examples?

Accessible and productive virtual meetings to help enable you to bring more people into attending and participating in how local issues get decided in a constructive way.



Digitized public-facing administrative functions on the website that help reduce staff time on OPRA or related requests, and provide your community with more information for them to help engage in a more informed way. Such as,

- Accessible electronic meeting agendas and minutes
- Interactive forms, applications and permits
- Electronic OPRA request form submission



#### Platforms that can provide:

- The ability for public to request services and report issues,
- Creation of infrastructure for internal workflows,
- Data collection and reporting to help inform future resource allocation.



Comprehensive local engagement strategies that help create clear pathways for the discussion and implementation of large-scale local programs or innovations that otherwise might seem too daunting or difficult to consider.



Visioning and goal-setting meeting frameworks that help ensure your key stakeholders can discuss, evaluate, and get on the same page about their goals.



#### Who is eligible?

- NJ municipality registered with Sustainable Jersey;
- Have an active green team;
- Population between 2,000 and 60,000; and
- Designate a key point of contact for the PIE Consultant to help coordinate activities.



#### What is the timeline?

- Sunday, August 9, 11:59pm Applications due bit.ly/PIETAapp2020
- End of August Notification of four participating municipalities
- Early September Work begins!
- End of November Work wraps up
- By end of the year Local PIE Plans released



#### How are municipalities selected?

### Committee of Sustainable Jersey staff & consultant will base decision on the following criteria:

- NJ municipality registered in SJ program with active green team;
- Completion of authorization form, signed by mayor & administrator;
- Demonstrated commitment to the process via responses to application questions;
- Responsiveness to follow up interviews; and
- Current & past progress in PIE actions.
