
# **Eligibility Requirements For Previous Grant Recipients**

Applicants who received a large (\$10,000 or more) grant from 2020 will be ineligible to apply in this cycle. Eligibility for previous grant recipients with open grants varies. 






















## **Eligible Projects**

Energy Reliability and Resiliency • Energy Conservation • Renewable Energy Building Electrification • Energy Efficiency • Studies, Plans, and Engineering Alternative Fuel Vehicles / Transportation Electrification













Applicants interested in purchasing alternative fuel vehicles are only eligible to apply for class 4-8 medium and heavy-duty vehicles such as.

- Delivery/Freight Trucks
- School, Shuttle, and Transit Buses
- Garbage Trucks
- Snow Removal Vehicles

# **Ineligible Projects**



### Lighting ONLY Upgrade Projects

This includes street lighting, stadium lighting, parking lot lighting, and other exterior and interior lighting. Direct Install projects for the replacement of HVAC equipment, boilers, etc. that also include lighting upgrades will still be considered.



#### Electric Vehicle Charging Station Purchases
