A. Background

Thanks to the support of New Jersey American Water, this opportunity is open to municipalities located in their service territory. Preference in the selection process will be given to low- and moderate-income (LMI) communities. LMI communities are municipalities with a median household income lower than \$65,392. A list of eligible municipalities can be found [here](#) and in Section F.

Municipalities face a myriad of water issues from localized flooding even on sunny days; to degraded water bodies that are unsafe for fishing and swimming, and to concerns about drinking water to name a few. The added threat of climate change to already stressed systems, serves as a strong reminder that preparations today to ensure future well-being is time well spent. Municipalities can play a significant role in creating a holistic and sustainable water system. One way to identify the key water issues your municipality faces is through the completion of a new action – Municipal Water Story.

Sustainable Jersey is offering FREE technical assistance to one registered or certified municipality interested in undertaking the newly released [Municipal Water Story](#) action. The goal of the action is for a municipality to define and prioritize their local water challenges. To do this a municipality will undertake a data collection process to create a narrative – a water story - that describes water in all its forms – drinking, waste, stormwater and as a natural resource. Municipalities are then charged with sharing the water story narrative to allow citizens to react to the facts, and enhance the story

with information from their experiences with water in order to provide a fuller picture. The Water Story is a first step to achieve the Gold Star Standard in Water and is intended to serve as a catalyst for a wider discussion in the community to formulate an overall water strategy.

Sustainable Jersey staff will provide the technical assistance to the selected municipality for approximately 16-20 weeks during summer and fall of 2021. The assistance will be tailored to the specific needs of the selected municipality and will include coaching for local green team volunteers and municipal staff to guide them through each step of the action. Sustainable Jersey staff will be available to answer questions, provide resources, and advise and assist the municipality in crafting their Water Story. The goal of this effort is assisting a municipality in completing the action and to produce an example of a Municipal Water Story to be featured in the “Spotlight: What NJ municipalities are doing” section of the action.

Due to the COVID-19 pandemic, the technical assistance will be provided remotely. Applicants should be prepared to support collaborative work in an online environment.

The selected municipality will be expected to:

- Identify a minimum of two municipal contacts: at least one must be a municipal staff member and the other(s) can also be staff or volunteers from the green team, environmental commission or other municipal group, to undertake the work outlined in the action.
- Participate in a series of zoom meetings organized and facilitated by Sustainable Jersey staff including, but not limited to, a kick-off call, five to seven check-in meetings and a debrief call. Prior to these meetings, municipal contacts will need to review background information, gather information, and comment on draft materials prepared by Sustainable Jersey staff
- Undertake an inclusive public engagement process to gain broad input from the municipality on the Water Story and identify and prioritize municipal water issues.
- Co-present with Sustainable Jersey staff the Municipal Water Story – findings, issues and priority – to municipal decisionmakers.
- Submit the Municipal Water Story as part of its next Sustainable Jersey municipal certification application.
- Provide feedback on the guidance provided in the Municipal Water Story action.

B. Eligibility Requirements

To be eligible to apply for the 2021 Municipal Water Story Technical Assistance program, an applicant must:

- Be a New Jersey municipality registered or certified in Sustainable Jersey (use this [link](#) for information on how to register you municipality in Sustainable Jersey); and
- Be a New Jersey municipality located in New Jersey American Water’s service territory.

C. Selection Process

A committee of Sustainable Jersey staff will review the applications. During the selection process, an interview with municipal personnel to assess this program's potential match may be requested. Interviews would take place in late June/early July. **Applicants must be responsive to this interview request to be considered for the program in late June.**

Applications will be screened based on the Eligibility Requirements outlined in [Section B](#) and evaluated based on the criteria outlined below:

- Responsiveness to selection committee interview, if requested
- Demonstrated commitment to respond to Sustainable Jersey staff requests for data and other information needed to assist the municipality in the completion of the Municipal Water Story
- Preference in the selection process will be given to low- and moderate-income (LMI) communities. LMI communities are municipalities with a median household income lower than \$65,392. A list of eligible municipalities can be found [here](#) and in Section F.

NOTE: *If submitting a resolution, it would be best to start the process of obtaining this resolution as early as possible to allow enough time to have the resolution adopted. The approved resolution should be submitted with the application by the June 24, 2021 deadline. Applications will be accepted with a proposed resolution and the date it will be presented to the governing body.
